

TIFF Twitter Contest for *My Policeman* Premiere

(THE “CONTEST”)

This Contest is open to all Canadian legal residents living in Canada (excluding Quebec residents) and is governed by Canadian law.

1. CONTEST PERIOD:

The Contest begins on September 9th 2022, at 9am Eastern Time (ET) and ends September 10th 2022, at 9am ET (the “**Contest Period**”).

2. ELIGIBILITY:

The Contest is open to all Canadian legal residents (excluding Quebec residents) who are age of majority or older in their province or territory of residence at the date of entry. The Contest is not open to employees, representatives, or agents (and those with whom such persons are immediate family members of or domiciled with) of Toronto International Film Festival Inc. (“**TIFF**” or “**Sponsor**”), or Sponsor’s respective parent companies, subsidiaries, affiliates, distributors, prize suppliers, and advertising/promotion agencies (collectively, the “**Contest Parties**”).

3. HOW TO ENTER:

No purchase necessary. Void where prohibited. Enter the Contest via TIFF's Twitter (@TIFF_NET) during the Contest Period ("**Entry**"). Entrants who have submitted their entry during the Contest Period will be entered into a random draw at the end of the Contest Period for a chance to win one (1) pair of tickets to *My Policeman* premiere ("**Eligible Entry**").

There is a limit of one (1) Entry per person permitted during the Contest Period. For greater certainty, you can only use one (1) Twitter account to enter the Contest. If it is discovered that you have attempted to: (i) submit more than one (1) Entry per person during the Contest Period; or (ii) use more than one (1) Twitter account to enter the Contest, then (in the sole discretion of TIFF) you may be disqualified from the Contest and all of your Entries may be voided. Your Entry will automatically be rejected if it is not fully completed and/or if it is submitted outside the Contest Period. Use of any automated system to enter or participate in this Contest is prohibited and will automatically result in disqualification.

There will be 1 prize available to be won, consisting of 2 tickets to *My Policeman* premiere, taking place at The Princess of Wales Theatre on SEPTEMBER 11TH 2022 AT 6:30PM (the "**Prize**"). The total approximate retail value of the Prize is \$112.00 CAD. **NO**

Contest Parties bear no responsibility if any event, element or detail of the Prize, including without limitation *My Policeman* premiere, is canceled, postponed or becomes unavailable for any reason. The winner and his/her guest shall be subject to all terms and conditions printed on any ticket issued in conjunction with the Prize. Sponsor does not guarantee any type of meeting or photo opportunity with any special guests or talent that may be involved in *My Policeman* premiere. In the event the winner and/or guest engage in behavior that, as determined by Sponsor, in their sole discretion, is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate any element of the Prize early, in whole or in part, and send the winner and/or his or her guest home, with no further compensation. 4. RANDOM PRIZE DRAW AND WINNER SELECTION:

A random draw will be held on or about SEPTEMBER 10TH 2022 (the "**Draw Date**") in Toronto, Ontario, at approximately 12PM ET. 1 entrant will be selected from all Eligible Entries. The odds of winning depend on the number of competing Eligible Entries received during the Contest Period.

Sponsor or its designated representative will make 1 attempt to contact the selected entrant by email using the address associated with the selected entrant's account within 1 business day of the Draw Date. If the selected entrant cannot be contacted within 1 attempt or 2 business days of the Draw Date (whichever occurs first), or there is a return of any notification as undeliverable, then the selected entrant will be disqualified and Sponsor reserves the right, in its sole discretion, to randomly select an alternate eligible entrant from among the remaining Eligible Entries.

Before being declared a winner, the selected entrant will be required to: (a) correctly answer a mathematical skill-testing question without mechanical or other aid; and (b) sign and return within 2 business days of notification Sponsor's Declaration and Release form, which (among other things): (i) confirms compliance with these Official Contest Rules (the "**Rules**"); (ii) acknowledges acceptance of the Prize as awarded; (iii) releases the Contest Parties and each of their respective officers, directors, agents, representatives, successors, and assigns (collectively, the "**Releasees**") from any and all liability in connection with this Contest, the selected entrant's participation therein, and/or the awarding and use/misuse of the Prize or any portion thereof; and (iv) agrees to the publication, reproduction, and/or other use of the selected entrant's name, address, voice, statements about the Contest, and/or photograph or other likeness without further notice or compensation, in any publicity or advertisement carried out by Contest Parties in any manner whatsoever, including print, broadcast, or the internet. If the selected entrant: (a) fails to correctly answer the skill-testing question; and/or (b) fails to return the properly executed Contest documents within the specified time, then he/she/they will forfeit the Prize and Sponsor reserves the right, in its sole discretion, to randomly select an alternate eligible entrant from among the remaining Eligible Entries.

IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE,
AND/OR NON-INFRINGEMENT.

All Entries become the property of Sponsor. The Releasees assume no responsibility for lost, delayed, incomplete, incompatible, or misdirected Entries. This Contest is subject to all applicable federal, provincial, and municipal laws. The decisions of Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of Entries and/or entrants.
