TIFF 22 Feedback Survey Prizes

(THE "CONTEST")

This Contest is open to all Canadian legal residents living in Canada (excluding Quebec residents) and is governed by Canadian law.

1. CONTEST PERIOD:

The Contest begins on Tuesday 20th September at 9am Eastern Time (ET) and ends Sunday 2nd October at 11:59pm time ET (the "**Contest Period**").
