

TIFF Twitter Contest Secret Movie Club ticket giveaway.

(THE “CONTEST”)

This Contest is open to all Canadian legal residents living in Canada (excluding Quebec residents) and is governed by Canadian law.

1. CONTEST PERIOD

The Contest begins on Weds, Dec 7th 2022, at 10am Eastern Time (ET) and ends, Friday 9th 2022, 3pm ET (the “**Contest Period**”).

2. ELIGIBILITY:

The Contest is open to all Canadian legal residents (excluding Quebec residents) who are age of majority or older in their province or territory of residence at the date of entry. The Contest is not open to employees, representatives, or agents (and those with whom such persons are immediate family members of or domiciled with) of Toronto International Film Festival Inc. (“**TIFF**” or “**Sponsor**”), or Sponsor’s respective parent companies, subsidiaries, affiliates, distributors, prize suppliers, and advertising/promotion agencies (collectively, the “**Contest Parties**”).

3. HOW TO ENTER:

No purchase necessary. Void where prohibited. Enter the Contest via TIFF’s twitter (@tiff_net) during the Contest Period (“**Entry**”). Entrants who have submitted their entry during the Contest

Period will be entered into a random draw at the end of the Contest Period for a chance to win one (1) pair of tickets to a *Secret Movie Club screening*.

(“**Eligible Entry**”).

There is a limit of one (1) Entry per person permitted during the Contest Period. For greater certainty, you can only use one (1) twitter account to enter the Contest. If it is discovered that you have attempted to: (i) submit more than one (1) Entry per person during the Contest Period; or (ii) use more than one (1) twitter account to enter the Contest, then (in the sole discretion of TIFF) you may be disqualified from the Contest and all of your Entries may be voided. Your Entry will automatically be rejected if it is not fully completed and/or if it is submitted outside the Contest Period. Use of any automated system to enter or participate in this Contest is prohibited and will automatically result in disqualification.

There will be one (1) prize available to be won, consisting of two (2) tickets to a *Secret Movie Club screening*, taking place at TIFF Bell Lightbox on Tuesday, Dec 13th 2022 at 7:00PM (the “**Prize**”). The total approximate retail value of the Prize is \$40.00 CAD. **NO TRANSPORTATION IS INCLUDED WITH THE PRIZE. ALL EXPENSES NOT SPECIFICALLY MENTIONED HEREIN ARE NOT INCLUDED AND ARE SOLELY A WINNER’S RESPONSIBILITY, INCLUDING BUT NOT LIMITED TO TRANSPORTATION BETWEEN A WINNER’S RESIDENCE AND HOTEL ACCOMMODATIONS (AND OTHER EXPENSES) THAT MAY BE ASSOCIATED WITH ATTENDING.**

Contest Parties bear no responsibility if any event, element or detail of the Prize, including without limitation to *the Secret Movie Club screening*, is canceled, postponed or becomes unavailable for any reason. The winner and his/her guest shall be subject to all terms and conditions printed on any ticket issued in conjunction with the Prize. In the event the winner and/or guest is denied entry into any ticketed location or is removed or barred from any ticketed location for any other reason, Contest Parties are not responsible and no further compensation or award will be provided.

Sponsor does not guarantee any type of meeting or photo opportunity with any special guests or talent that may be involved in *the screening of the Secret Movie Club screening*. In the event the winner and/or guest engage in behavior that, as determined by Sponsor, in their sole discretion, is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate any element of the Prize early, in whole or in part, and send the winner and/or his or her guest home, with no further compensation. Winner and guest must obey all rules and complete any paperwork required for the Prize, including but not limited to any additional releases, contracts, non-disclosure agreements, waivers required by the Sponsor, and failure to sign such paperwork and/or to furnish all required information on dates selected by Sponsor in their sole discretion will result in forfeiture of the Prize.

The Prize will only be awarded to the person whose full name and valid email address are associated with the winning account.

4. RANDOM PRIZE DRAW AND WINNER SELECTION:

A random draw will be held on or about Friday Dec 9th (the "**Draw Date**") in Toronto, Ontario, at approximately 4pm ET. One (1) entrant will be selected from all Eligible Entries. The odds of winning depend on the number of competing Eligible Entries received during the Contest Period.

Sponsor or its designated representative will make one (1) attempt to contact the selected entrant by email using the address associated with the selected entrant's account within one (1) business day of the Draw Date. If the selected entrant cannot be contacted within one (1) attempt or one (1) business days of the Draw Date (whichever occurs first), or there is a return of any notification as undeliverable, then the selected entrant will be disqualified and Sponsor reserves the right, in its sole discretion, to randomly select an alternate eligible entrant from among the remaining Eligible Entries.

Before being declared a winner, the selected entrant will be required to: (a) correctly answer a mathematical skill-testing question without mechanical or other aid; and (b) sign and return within one (1) business days of notification Sponsor's Declaration and Release form, which (among other things): (i) confirms compliance with these Official Contest Rules (the "**Rules**"); (ii) acknowledges acceptance of the Prize as awarded; (iii) releases the Contest Parties and each of their respective officers, directors, agents, representatives, successors, and assigns (collectively, the "**Releasees**") from any and all liability in connection with this Contest, the selected entrant's participation therein, and/or the awarding and use/misuse of the Prize or any portion thereof; and (iv) agrees to the publication, reproduction, and/or other use of the selected entrant's name, address, voice, statements about the Contest, and/or photograph or other likeness without further notice or compensation, in any publicity or advertisement carried out by Contest Parties in any manner whatsoever, including print, broadcast, or the internet. If the selected entrant: (a) fails to correctly answer the skill-testing question; and/or (b) fails to return the properly executed Contest documents within the specified time, then he/she/they will forfeit the Prize and Sponsor reserves the right, in its sole discretion, to randomly select an alternate eligible entrant from among the remaining Eligible Entries.

WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, THE PRIZE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND THE RELEASEES HEREBY DISCLAIM ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND/OR NON-INFRINGEMENT.

All Entries become the property of Sponsor. The Releasees assume no responsibility for lost, delayed, incomplete, incompatible, or misdirected Entries. This Contest is subject to all applicable federal, provincial, and municipal laws. The decisions of Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of Entries and/or entrants.

Failure to provide such proof in a timely manner may result in disqualification. The sole determinant of the time for the purposes of a valid Entry in this Contest will be Sponsor's server machine(s).

Sponsor reserves the right to withdraw or amend this Contest (or to amend these Rules) in any way, in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure, or any other cause beyond the reasonable control of Sponsor that interferes with the proper conduct of this Contest as contemplated by these Rules.
