# The Idea of You Instagram Contest

# THIS CONTEST IS OPEN TO CANADIAN RESIDENTS ONLY (EXCLUDING QUEBEC) AND IS GOVERNED BY CANADIAN LAW.

#### 1. CONTEST PERIOD:

The contest begins Friday, Apr 19, 2024 at 10:00 am Eastern Time (ET) and ends Sunday, Apr 21, 2024 at 11:59 pm ET (the "Contest Period").

## 2. ELIGIBILITY:

The Contest is open to all Canadian legal residents (excluding Quebec residents) who are age of majority or older in their province or territory of residence at the date of entry. The Contest is not open to employees, representatives, or agents (and those with whom such persons are domiciled) of Toronto International Film Festival Inc. ("TIFF" or the "Sponsor") or the Sponsor's respective parent companies, subsidiaries, affiliates, distributors, prize suppliers, and advertising/promotion agencies (collectively, the "Contest Parties").

#### 3. HOW TO ENTER:

NO PURCHASE NECESSARY. Void where prohibited. To enter, visit TIFF Instagram (https://www.instagram.com/tiff\_net/?hl=en) during the Contest Period (the "**Entry**"). Entrants who have submitted an Entry during the Contest Period will be entered into a random draw at the end of the Contest Period for a chance to win one (1) pair of tickets to *TIFF Advance Screening: The Idea of You*.

There is a limit of one (1) Entry per person permitted during the Contest Period. For greater certainty, you can only use one (1) Instagram account to enter the Contest. If it is discovered that you have attempted to: (i) submit more than one (1) Entry per person during the Contest Period; or (ii) use more than one (1) Instagram account to enter the Contest, then (in the sole discretion of the Sponsor) you may be disqualified from the Contest and all of your Entries may be voided. Your Entry will automatically be rejected if it is not fully completed and/or is submitted

outside the Contest Period. Use of any automated system to enter or participate in this Contest is prohibited and will automatically result in disqualification.

#### 4. THE PRIZE AND APPROXIMATE RETAIL VALUE:

There will be one (1) Prize available to be won, consisting of two (2) tickets to the *TIFF Advance Screening: The Idea of You* event (the "**Prize**"). The Prize must be accepted as awarded and is not transferable. No substitutions. Without limiting the generality of the foregoing, the following general conditions apply to the Prize: (i) the Prize must be accepted as awarded and is not transferable or convertible to cash (no substitutions except at the Sponsor's option); (ii) if the winner does not utilize any part(s) of the Prize, then any such part(s) not utilized will be forfeited in their entirety and nothing will be substituted in their place; (iii) the Sponsor reserves the right at any time to: (a) place reasonable restrictions on the availability or use of the Prize or any component thereof; and (b) substitute the Prize or a component thereof for any reason with a prize or a prize component of equal or greater value, including, without limitation but solely at the Sponsor's sole discretion, a cash award; (iv) by accepting the Prize, the winner agrees to waive all recourse against the Releasees (as defined below) if the Prize or a component thereof does not prove satisfactory, either in whole or in part. The Prize will only be awarded to the person whose full name and valid email address are associated with the winning account.

#### 5. RANDOM PRIZE DRAW AND WINNER SELECTION:

On or around Monday, Apr 22, 2024 (the "**Draw Date**") in Toronto, Ontario, at approximately 12pm ET, one (1) entrant will be selected from all Eligible Entries. The odds of winning depend on the number of competing Eligible Entries received during the Contest Period. The Sponsor or its designated representative will make three (3) attempts to contact the selected entrant by email using the address associated with the selected entrant's account within five (5) business days of the Draw Date. If the selected entrant cannot be contacted within three (3) attempts or five (5) business days of the Draw Date (whichever occurs first), or there is a return of any notification as undeliverable, then the selected entrant will be disqualified and the Sponsor reserves the right, in its sole discretion, to randomly select an alternate eligible entrant from among the remaining Eligible Entries.

WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, THE PRIZE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND THE RELEASEES HEREBY DISCLAIM ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND/OR NON-INFRINGEMENT.

All Entries become the property of the Sponsor. The Releasees assume no responsibility for lost, delayed, incomplete, incompatible, or misdirected Entries. This Contest is subject to all applicable federal, provincial, and municipal laws. The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of Entries and/or entrants.

The Releasees will not be liable for any failure, error, or omission of the website during the Contest; for any technical malfunction or other problems relating to the telephone network or lines, computer online systems, servers, access providers, computer equipment, or software; for the failure of any entry to be received by the Sponsor for any reason including, but not limited to, technical problems or traffic congestion on the internet or at any website; or for any combination of the above.
