TIFF Primetime: Severance Season 2 Wishpond Contest

THIS CONTEST IS OPEN TO CANADIAN RESIDENTS ONLY (EXCLUDING QUEBEC)
AND IS GOVERNED BY CANADIAN LAW.

1. CONTEST PERIOD:

The contest begins Sunday, Feb 23, 2025 at 10:00 am Eastern Time (ET) and ends Sunday, March 2, 2025 at 11:59 pm ET (the "Contest Period").

2. ELIGIBILITY:

The Contest is open to all Canadian legal residents (excluding Quebec residents) who are age of majority or older in their province or territory of residence at the date of entry. There is a limit of one (1) Entry per person permitted during the Contest Period. For greater certainty, you can only use one (1) Instagram account to enter the Contest. If it is discovered that you have attempted to: (i) submit more than one (1) Entry per person during the Contest Period; or (ii) use more than one (1) Instagram account to enter the Contest, then (in the sole

discretion of the Sponsor) you may be disqualified from the Contest and all of your Entries may be voided. Your Entry will automatically be rejected if it is not fully completed and/or is submitted outside the Contest Period. Use of any automated system to enter or participate in this Contest is prohibited and will automatically result in disqualification.

4. THE PRIZE AND APPROXIMATE RETAIL VALUE:

There will be one (1) Prize available to be won, consisting of two (2) tickets to the TIFF Primetime: Severance Season 2 event (the "Prize"). The Prize must be accepted as awarded and is not transferable. No substitutions. The Sponsor or its designated representative will make three (3) attempts to contact the selected entrant by email using the address associated with the selected entrant's account within five (5) business days of the Draw Date.
