TIFF x MUBI Sweater Wishpond Contest

THIS CONTEST IS OPEN TO CANADIAN RESIDENTS ONLY (EXCLUDING QUEBEC) AND IS GOVERNED BY CANADIAN LAW.

1. CONTEST PERIOD:

The contest begins Monday, Feb 24, 2025 at 10:00 am Eastern Time (ET) and ends Wednesday, March 5, 2025 at 11:59 pm ET (the "**Contest Period**").

2. ELIGIBILITY:

The Contest is open to all Canadian legal residents (excluding Quebec residents) who are age of majority or older in their province or territory of residence at the date of entry.
