Next Wave Survey Contest

THIS CONTEST IS OPEN TO CANADIAN RESIDENTS ONLY (EXCLUDING QUEBEC) AND IS GOVERNED BY CANADIAN LAW.

1. CONTEST PERIOD:

The contest begins Tuesday, April 16, 2024 at 10:00 am Eastern Time (ET) and ends Wednesday, May 1, 2024 at 11:59 pm ET (the "Contest Period").

2. ELIGIBILITY:

There is a limit of one (1) Entry per person permitted during the Contest Period. For greater certainty, you can only use one (1) Instagram account to enter the Contest. If it is discovered that you have attempted to: (i) submit more than one (1) Entry per person during the Contest Period; or (ii) use more than one (1) Instagram account to enter the Contest, then (in the sole discretion of the Sponsor) you may be disqualified from the Contest and all of your Entries may be voided. Your Entry will automatically be rejected if it is not fully completed and/or is submitted

outside the Contest Period. Use of any automated system to enter or participate in this Contest is prohibited and will automatically result in disqualification.

There will be one (1) Prize available to be won, consisting of two (2) tickets to the Festival 24' Opening Night Film event (the "Prize").
