State Assembly Person Robert Carroll

Patti Veconi introduced our guest speaker, Robert Carroll, the State Assembly person for the 44th district. He spoke about his background growing up in Brooklyn and his desire for a better city and state. His principal interests as a legislator are:

<u>The Environment</u>. He supports the Build Public Renewables Act which mandates the New York Power Authority to try to convert from fossil fuel plants to renewable energy, as well as the All Electric New Buildings Act. He also supports banning bitcoin mining in New York state.

Mass Transit. He feels NYC residents carry an undue burden paying for services which benefit the entire metro area.

<u>Education and Literacy</u>. He feels every child should be able to read and testing for Dyslexia in school is very important.

Election Law. He favors election law reform including more early voting and ranked choice voting.

He mentioned that congestion pricing, traffic and lack of parking are topics that generate a lot of feedback from his constituents.
