- Teddy mentioned it is possible for us to plant our own trees. Seth added that the city has an extensive backlog of sites needing trees resulting in long delays. It was decided to table the discussion until Den Gordon returns as she has a great deal of information regarding the tree issue.

supplement PPUABA publicity for the sale.

Nourishing our Community
