2. Participation period

The raffle runs from 25 July 2026 (00:00) to 8 September 2026 (23:59) (the “Participation Period”).

Participation is only possible within the Participation Period. Orders received after the closing date will not be included in the prize draw.

3. Eligibility

Persons aged 18 and over who are resident in Germany and hold a customer account on www.amorelie.de (or create one as part of the order) are eligible to participate.

Employees of the Wolt Enterprises GmbH and its affiliated companies, as well as their relatives, are excluded from participating in the raffle.

Participation with fake identities or with the identities of third parties is not permitted. If the excluded participant is already a winner, the prize may be revoked retrospectively.

4. How the raffle works

Participants can enter the raffle as follows:

- a. During the Participation Period, the participant places an order on www.wolt.de and enters the promotional code “PRIDE26” at checkout.
- b. When the promotional code “PRIDE26” is entered, a discount of €0.01 is displayed at checkout.
- c. The order is accepted, confirmed and successfully delivered by AMORELIE (“successful entry”). Cancelled or undelivered orders are not considered successful entries.

Once the successful order has been completed (including receipt of the purchase confirmation/invoice), the participant is registered as a participant in the prize draw.

Each further successful order placed with the promotional code during the Participation Period counts as an additional entry; multiple entries are possible accordingly. The promotional code only needs to be entered once per order at checkout.

5. Prizes

7. Exclusion and termination

The Organiser reserves the right to exclude individuals from the raffle who violate these Terms and Conditions, in particular those reasonably suspected of using unauthorised aids or otherwise attempting to gain an advantage for themselves or third parties through manipulation. In such cases, prizes may also be revoked and reclaimed retrospectively.

The Organiser reserves the right to terminate the raffle without prior notice for good cause, in particular in cases of suspected manipulation.

8. Data protection

The collection and processing of personal data for the purposes of conducting this raffle is carried out in accordance with Art. 6 (1) sentence 1 lit. b) GDPR by Wolt Enterprises Deutschland GmbH Stralauer Allee 6 10245 Berlin.

Data collected as part of participation is used exclusively for conducting the raffle, determining and notifying winners, and shipping prizes, and will not be passed on to third parties for other purposes.

Each winner's personal data will only be stored, processed and used for the purposes of the raffle.
