## Tiger Rentals Refinances \$160 Million Credit Facilities; Includes \$100 Million Term Loan from Orion Energy Partners and \$60 Million Revolving Credit Facility from J.P. Morgan

(together with its affiliated funds, "**Orion Energy**") and a \$60 million working capital revolving credit facility with JPMorgan Chase Bank, N.A. (together with its affiliates, "**J.P. Morgan**"). The refinancing provides significantly improved pricing and terms that reflect the Company's strong financial performance and current market conditions.
