## **Diurnal Limited / Neurocrine UK Limited 'Diurnal' - ABPI Disclosure of Transfers of Value to Patient Organisations for 2024**

Diurnal is part of the Neurocrine Biosciences group of companies and operates as a wholly owned subsidiary of Neurocrine Biosciences Inc. Diurnal changed its registered company name from Diurnal Limited to Neurocrine UK Limited, effective from 21 October 2024. Disclosures for the full year of 2024 are reported in the name of Diurnal, since this approach best enables full transparency for relevant payments made by the entity during that year. From 2025 onwards Disclosures will be reported in Diurnal's new name of Neurocrine UK Limited. For the purposes of this note, 'Diurnal' shall mean the company Diurnal Limited, now known as Neurocrine UK Limited.

Diurnal is committed supporting the important work of patient organisations and to working with them on specific projects where there is a shared interest and benefit to patients. In all our interactions with patient organisations, we strive to build relationships based on mutual respect and transparency.

Diurnal adheres to the Association of the British Pharmaceutical Industry (ABPI) Code of Practice, making publicly available annually, a list of patient organisations to which it provides donations, grants or sponsorship (including in relation to events/meetings) or with whom it has engaged to provide contracted services over the reporting period.

This note discloses the methodologies used by Diurnal in preparing disclosures in compliance with ABPI Code of Practice.

### **Requirements of the ABPI Code:**

In accordance with Clause 29 of the ABPI code:

*29.1 Companies must make publicly available annually, a list of patient organisations to which it provides donations, grants or sponsorship (including in relation to events/meetings) or with whom it has engaged to provide contracted services over the reporting period. This information must be disclosed on the company website either on a national or European level. Each reporting period shall cover a full calendar year. Each company must include a note of methodologies used by it in preparing the disclosures and identifying support and contracted services provided.*

*29.2 The disclosure for the provision of donations, grants or sponsorship (including in relation to events/meetings) to a patient organisation must include:*

- the monetary value of each financial contribution (grant or sponsorship) to include a description that is sufficiently complete to enable the reader to understand the nature of that support or the arrangements in accordance with Clauses 23 and 10*
- the monetary value for each non-financial and/or indirect support (donation); the published information must also include a clear description of each donation that is sufficiently complete to enable the reader to understand the nature of the support or the arrangements. If the non-financial and/or indirect support (donation) cannot be assigned a meaningful monetary value, the published information must describe clearly the non-monetary value that the organisation receives that is sufficiently complete to enable the reader to understand the nature of the support or the arrangements in accordance with Clause 23.*

*The disclosure for contracted services provided by each patient organisation, in accordance with Clause 24, must include:*

- the total amount paid per patient organisation per calendar year including a description of the services provided that is sufficiently complete to enable the reader to understand the nature of the services provided without the necessity to divulge confidential information*
- fees and expenses should be disclosed separately.*

#### **Definitions:**

'Patient organisation' means an organisation mainly comprising of patients and/ or caregivers or any user organisation such as a disability organisation, carer or relative organisation and consumer organisation that represents and/or supports the needs of patients and/or caregivers.

'Individuals representing patient organisations' means a person who is mandated to represent and express the views of a patient organisation

#### **Financial Data:**

In preparing this note, payments and non-financial and/or indirect support to UK and European patient organisations made by any company in the Neurocrine Bioscience group during calendar year 2024 were reviewed, relevant transfers of value identified and additional information obtained where required. Amounts are reported in UK sterling. Where transfers of value were made in other currencies, for the purposes of our disclosure amounts were converted to UK sterling based on Neurocrine's Finance Department Monthly Average Rates. The total amount paid to the patient organisation was disclosed, which includes Value Added Tax (VAT) where this was included on the invoice. Where contracts are valid for more than one year, each individual payment is captured and disclosed in the reportable disclosure period.

#### **Inquiries:**

Diurnal will review and investigate any disputes with Patient Organisations relative to our disclosures. Any changes resulting from this review will be published in an updated report.
