

FACTS	WHAT DOES RIVIAN DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ■ Identifying and contact information, such as name, phone number, home address, email address, date of birth, social security number, driver’s license number ■ Financial information, such as income, housing information, and employment information ■ Vehicle information, such as vehicle identification number and vehicles sales information ■ Vehicle usage information, if you choose to share it for a potential insurance discount or other purposes ■ Business information (if a business is a co-applicant for a loan, business name, tax ID, address and phone number) <p>We use this information to provide you quotes, services, or to otherwise further our commercial relationship.</p>
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Rivian chooses to share; and whether you can limit this sharing.

How does Rivian protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Rivian collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ■ apply for financing through our consumer credit application ■ show your government issued identification ■ apply for insurance or file an insurance claim ■ authorize us to collect it, e.g., if you choose to participate in our insurance program <p>We may also collect your personal information from other companies, such as credit bureaus, when we process your quote or application.</p>

Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ■ sharing for affiliates' everyday business purposes—information about your creditworthiness ■ affiliates from using your information to market to you ■ sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include Rivian-branded companies, such as Rivian Automotive, Inc and Rivian Automotive, LLC.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Rivian does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

For insurance customers in AZ, CA, CT, GA, IL, ME, MA, MN, MT, NJ, NC, OH, OR and VA only. The term "Information" in this part means customer information obtained in an insurance transaction. We may give your Information to state insurance officials, law enforcement, group policy holders about claims experience or auditors as the law allows or requires. We may give your Information to insurance support companies that may keep it or give it to others. We may share Information so we can learn if you qualify for coverage, process claims or prevent fraud or if you say we can. To see or obtain access to your Information, please submit a request via our webform at rivn.co/prr. In your request, you must state your full name, address, the insurance company, policy number (if relevant) and the Information you want. We will tell you what Information we have and how you may correct, amend, or delete your Information. You may see and copy the Information (unless privileged) at our office or ask that we mail you a copy for a fee. If you think any Information is wrong, you must write us. We will let you know what actions we take. If you do not agree with our actions, you may send us a statement.
