Junction 13 of the M20 is located less than 0.5 miles to the west of the site.

The Port of Dover is approximately 8 miles to the east of the site, with an average 15 minute drive time.

Ashford is located 17 miles to the north-west of the site.

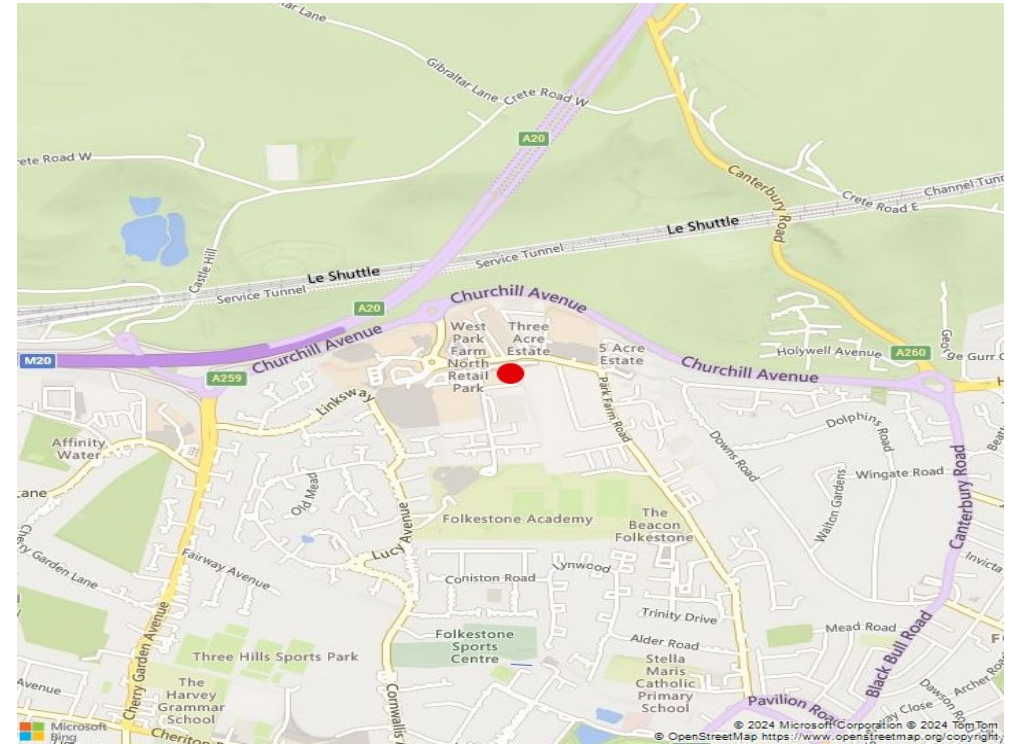
