LOCATION

Units 1 & 2 The Fireworks are located on an established industrial estate 1 miles from Axminster and 6.5 miles from Chard.

Nearby occupiers include Axminster Tools, Screwfix and Axminster kitchens.

DESCRIPTION

Units 1 & 2 are currently being refurbished with profile metal cladding to elevations, plastic coated pedestrian security doors to the front and fire exits to the rear to be constructed. Both units will have electric roller shutter doors, concrete floors, LED lighting, WC facilities and kitchenettes.

Each unit will have a concrete apron to front for unloading with the remainder of the yard which can be enclosed for storage and parking.

Unit 1 - G.I.A of 331.75 Sq M (3,570 Sq ft)

End of terrace industrial unit with a depth of 25.00m and a width 13.27m. Minimum eaves height of 6.51m and a maximum of 7.76m.

Plastic coated electric roller shutter door with a width of 4.05m and a height of 4.95m.

Unit 2 - G.I.A of 361.25 Sq M (3,887 Sq ft)

Mid of terrace industrial unit with a depth of 25.00m and a width 14.45m. Minimum eaves height of 6.51m and a maximum of 7.76m.

Plastic coated electric roller shutter door with a width of 4.00m and a height of 4.95m.

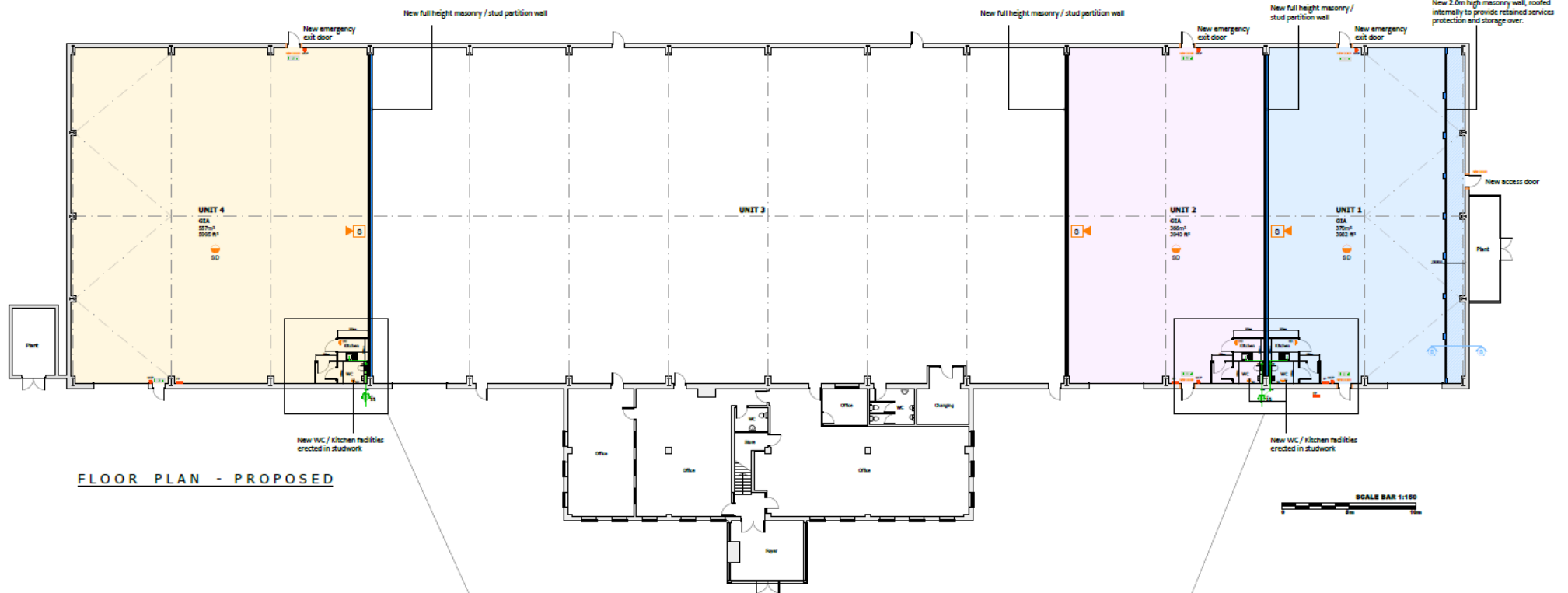

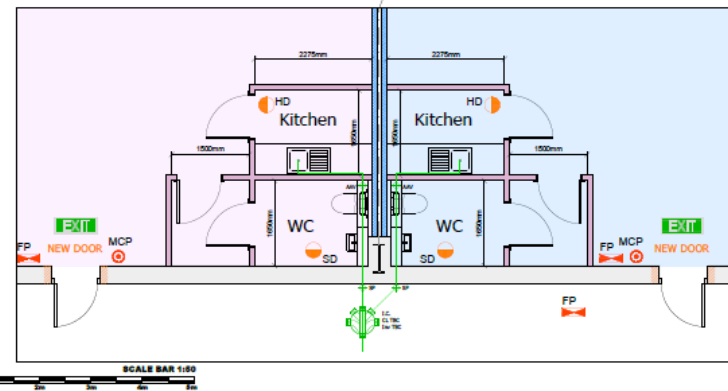

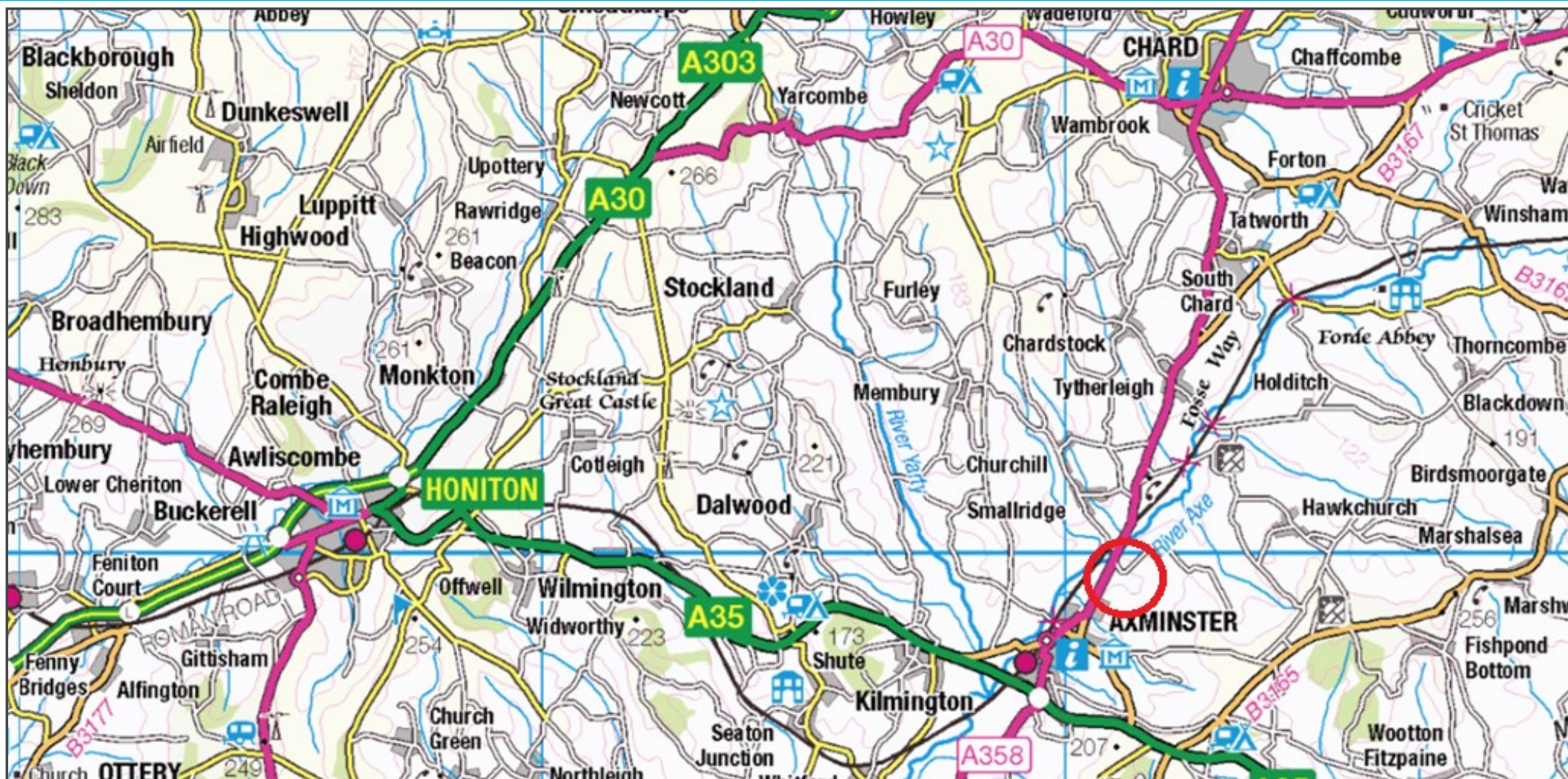




FLOOR PLAN - PROPOSED
