LOCATION

Unit 5 Isis Business Centre, is prominently situated at the front of the Isis Business Estate and commands one of the best locations visible to all those who enter. The Horspath trading estate is Oxford's primary trade location and home to many of the established operators such as HSS Hire, Screwfix, Toolstation and Chris Lewis Fire & Security amongst others.

The City of Oxford, as a major commercial centre, commands a strategic position close to the M40, A40 and A34 national road networks. Ideally placed, Horspath Industrial Estate is situated to the south of the city centre just off the Oxford Ring Road in the thriving commercial area of Cowley.

The Estate is within easy reach of Oxford City Centre, accessed via the Cowley Road and the A34 dual carriageway is within 1 mile of the estate. M40 is otherwise accessed at Junction 8.

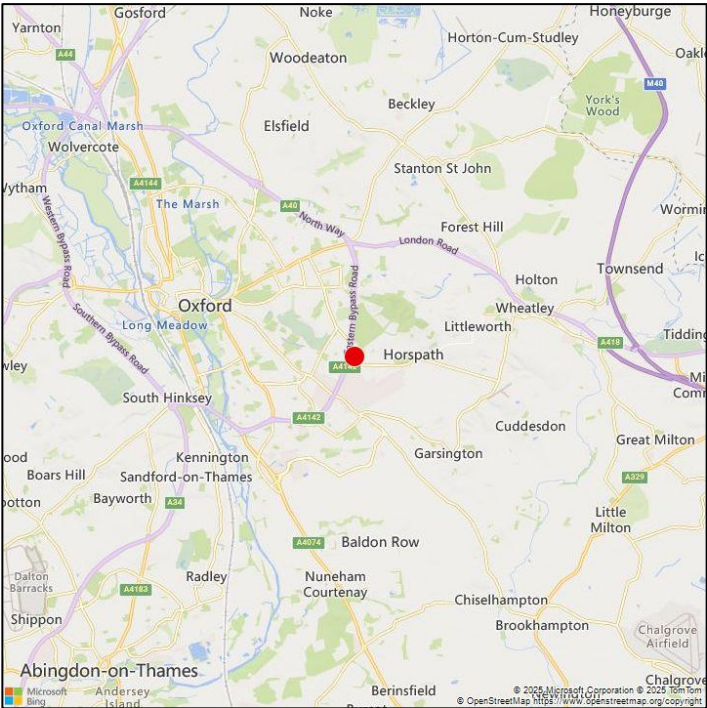
