Location

The site is situated in Burwell, Cambridgeshire, located approximately 11 miles northeast of Cambridge and 5 miles northwest of Newmarket. Burwell is situated only 3 miles from junction 37 of the A14, which provides good access to the wider national road network via the A1, M11 and M25.

The site's nearest rail link is Newmarket station (Approximately 5.4 miles), which provides regular direct services to Cambridge (25 mins) and Ipswich (50 Minutes).

Description

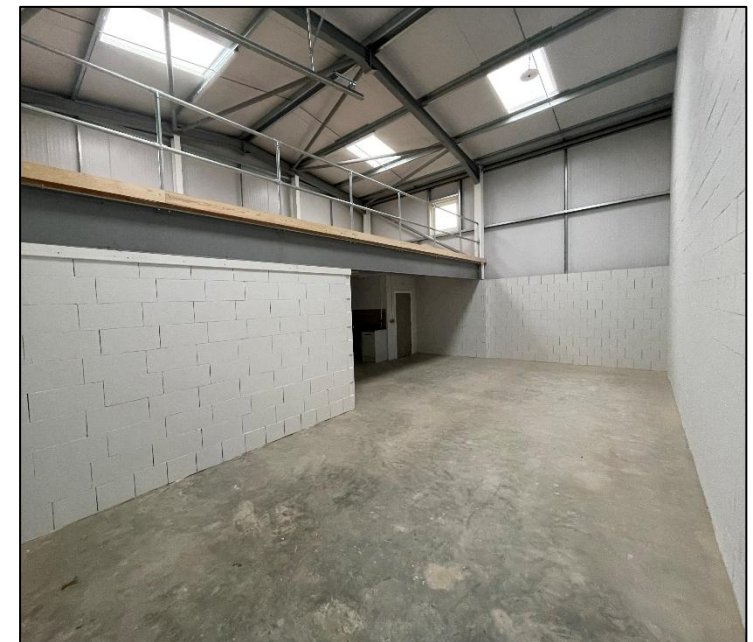
The site consists of 8 well-presented light industrial units of steel portal frame construction under a skillion roof with metal sheet cladding and brick elevations. Each provides warehouse, office and mezzanine accommodation.

The units are equipped with PV panels and electric car charging facilities. They benefit from an electric up and over insulated roller shutter door, 3 phase power, 5.9m minimum eaves and WC and kitchenette facilities. Additionally, the units come fitted with approximately 50% mezzanine coverage, providing 548 sq ft of additional accommodation.

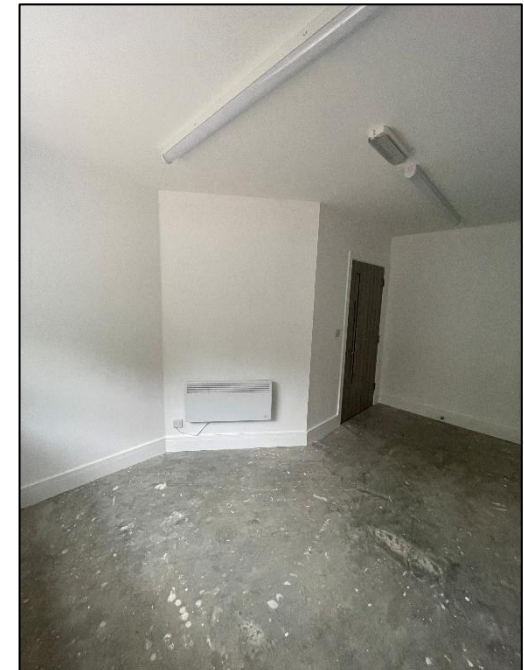

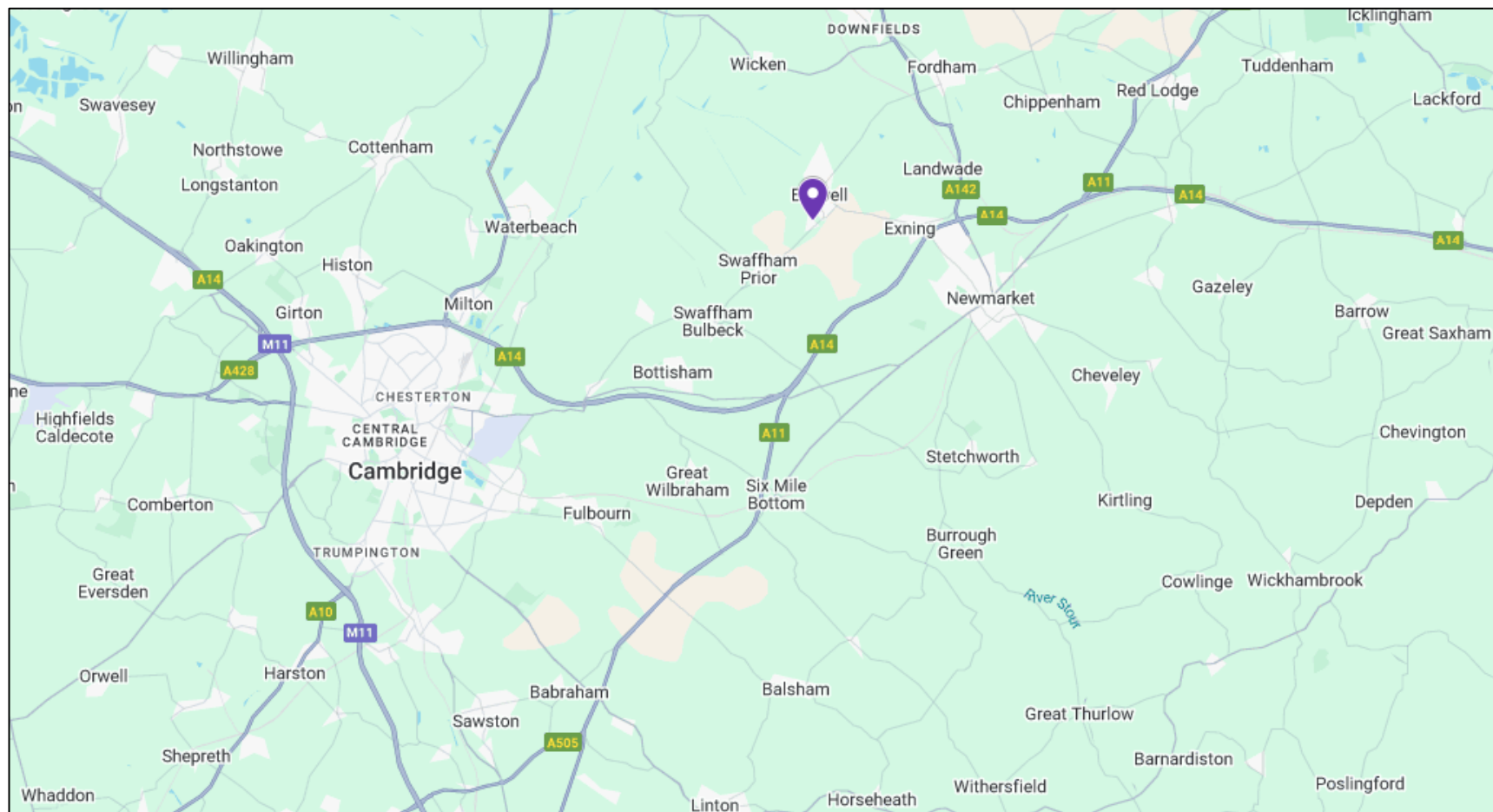
