Location

The property is located on Lensfield Road, Cambridge, a connecting Road between the Hills Road / Regent Street Junction and Trumpington Street. The property benefits from being roughly equidistant from Cambridge Train Station and the City Centre (approximately 900m). Lensfield Road exhibits a mixture of neighboring uses including, residential dwellings, Cambridge University's Yussef Hamied Department of Chemistry and The Lensfield Hotel.

Description

The property, is an attractive period building of solid brick construction situated in a prominent location on Lensfield Road. It has recently undergone significant refurbishment with internal specification now including LED lighting, secondary double glazing, carpeted flooring, AC, Kitchenette and WC facilities. The large windows provide excellent levels of natural light throughout. There is a small courtyard area on the eastern boundary of the property suitable for cycle parking and an attractive landscaped area to the front.

Accommodation is arranged over ground and first floors and suitable for a single tenant or to be taken on a floor by floor basis. The configuration is a combination of larger open plan rooms and smaller cellular offices.


