## LOCATION

Horsecroft Road sits within Harlow's established Pinnacles industrial estate, one of the town's principal commercial addresses. Junction 7 of the M11 is approximately 2 miles away, with the M25 (Junction 27) reachable in under 10 minutes, providing rapid access to Stansted Airport, the A10 corridor and Central London. Harlow Town station offers direct services into London Liverpool Street with journey times from around 40 minutes.

## DESCRIPTION

Plot 2 Horsecroft Road offers a 0.538 acre (23,444 sq ft) fully surfaced Industrial Outdoor Storage site within one of Essex's most strategically connected industrial locations. The site benefits from a tarmac surface throughout, palisade perimeter fencing, B8 planning consent with 24/7 access, and a meaningful power supply of 69 kVA with 3 phase connectivity - a combination rarely found at this scale in the IOS market.

Upgrade works have now completed, with the site ready for immediate occupation.
