Windsor Place is situated within Harlow, a key commercial centre in Essex with excellent connectivity. The site benefits from:

## DESCRIPTION

The property's Class 1 Carter Jonas IOS classification reflects its concrete surfacing, secure perimeter, services and established B8 consent - characteristics increasingly sought by occupiers.

The property comprises a secure IOS yard extending to approximately 30,000 sq ft. The site is concrete surfaced and benefits from a level, circular-shaped layout, making it highly efficient for a range of operational uses.

The yard provides both privacy and shared controlled access. Its circular configuration offers good potential for HGV access and on-site circulation, supporting a variety of commercial requirements.

The property is connected to mains power, water and drainage, and benefits from an established B8 planning consent. It is therefore well suited to a range of open storage uses, subject to any necessary planning considerations.

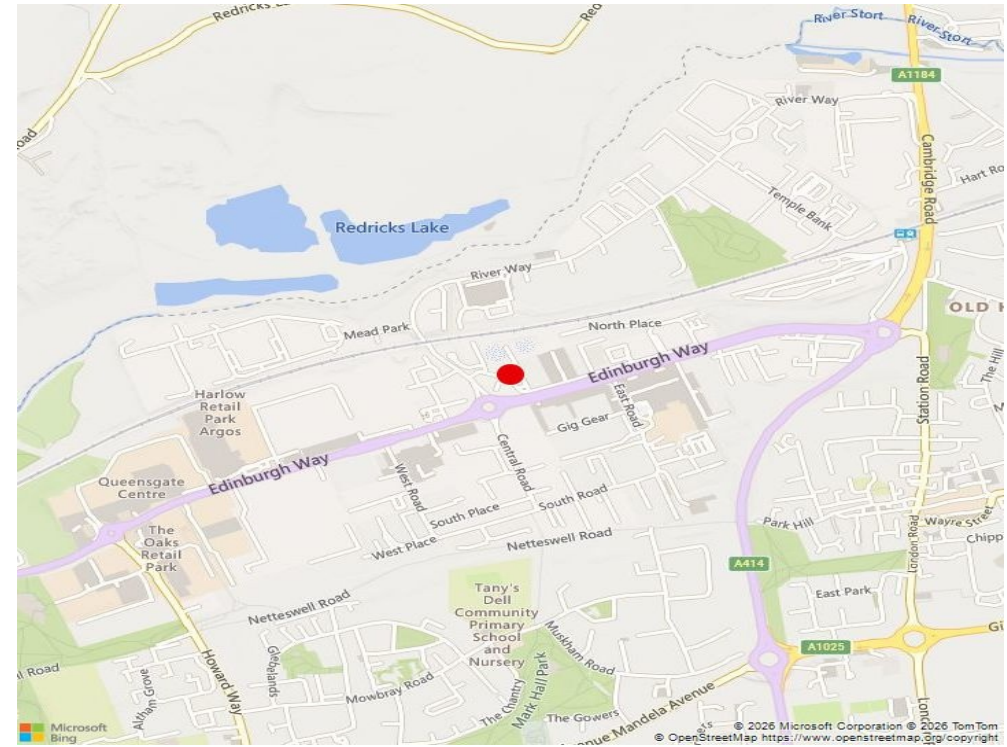
