LOCATION

Follingsby Park is a modern industrial estate extending to 110 acres at the centre of the Tyne & Wear conurbation with good access to Newcastle, Gateshead, Sunderland and South Tyneside.

The Park has direct access to a Motorway junction on the A194(M) giving easy access to the A1(M), the A19 and north to the Tyne Tunnel.

DESCRIPTION

Unit 18C has been recently refurbished and provides a detached industrial unit of steel portal frame construction with a mixture of blockwork base walls and insulated profile metal sheeting extending to the roof. The property has a minimum 6.5m eaves height and 3 loading doors. Internally, the unit comprises a ground floor warehouse with ground floor offices and a mezzanine above.

There is a yard area to the front of the unit with 12 car parking spaces.

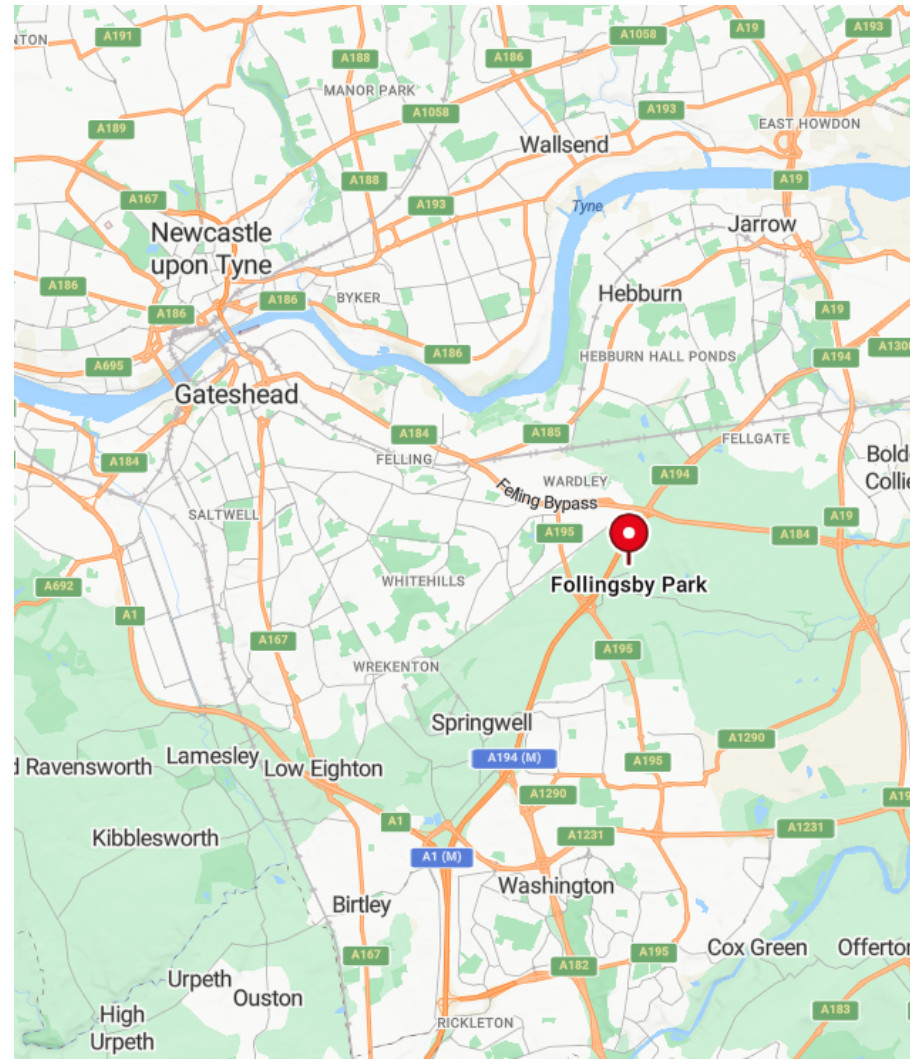

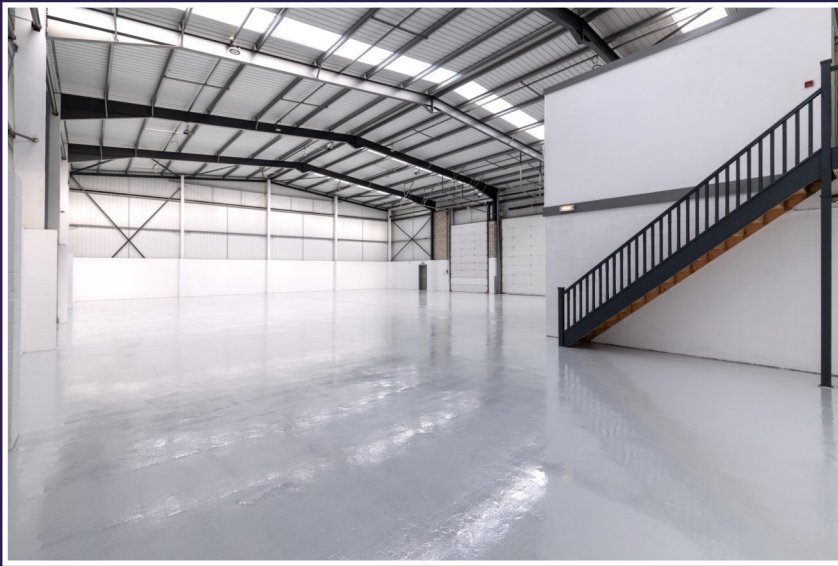
