LOCATION

The property is located at Chittening Road, adjacent to Chittening Industrial Estate, Avonmouth. The location benefits from close proximity to the motorway network, being just 3 miles from Junction 18 of the M5 and less than 10 miles from both the M4 and the Second Severn Crossing.

Bristol City Centre is approximately 10 miles to the South East, via the A4 Portway. The property is close to the extensive facilities of Bristol Port, being 2 miles from the entrance to Avonmouth Docks and 7 miles from Royal Portbury Docks, one of the largest deep water ports in the UK.

The property lies in the heart of the Avonmouth Severnside Enterprise Area; an industrial location of internationally significant scale, covering some 1,800 hectares. The area hosts large-scale industrial, warehouse and distribution, energy and waste processing uses, in addition to the activities of the port and its associated storage, distribution and support facilities.

DESCRIPTION

The property comprises a previously undeveloped site, situated adjacent to Chittening Industrial Estate. The site has an area of 4.5 acres (1.82 hectares).

SUBJECT TO CONTRACT

ACCOMMODATION

The property extends to approximately 4.5 acres.

RENT

Rent will be determined having regard to the terms of the proposed lease and will be payable quarterly in advance.

TENURE

The property is available by way of a new fully repairing and insuring lease for a term of years to be agreed.

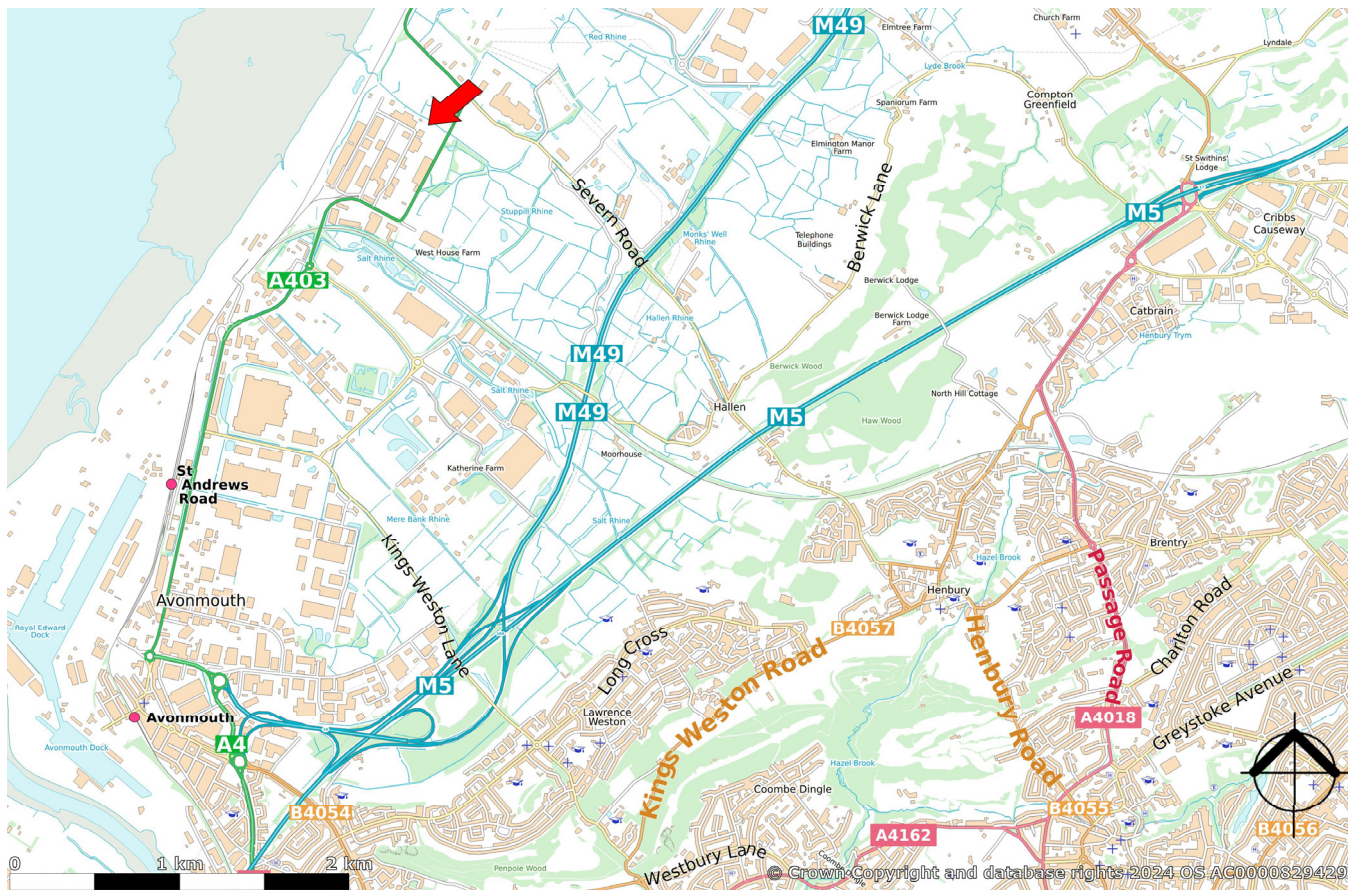
