

LOCATION

The Ilton Business Park is strategically placed for easy access on to the A303 via the A358 which also links to the M5 motorway at Junction 25 (Taunton) to the north, within 9 miles.

DESCRIPTION

The industrial unit is self-contained with profiled metal cladding to elevations. The unit provides warehousing and a disabled WC facility. The unit has 3-phase electricity, low-bay sodium lighting, a concrete floor and skylights.

Maximum eave height 8.94m. Minimum eave height 7.17m.

Pedestrian door and plastic coated roller shutter door to front with a width of 4.01m and a height of 6.01m.

Concrete yard to front with parking for 4/6 vehicles in tandem.




