**Location**  
The land at Caeathro occupies a useful position on the edge of the village of Caeathro. The nearest town of Caernarfon is less than two miles away and the city of Bangor is 10 miles away.

**Amenities**

The holding is situated 12 miles from busy livestock market Blynnyr and provides easy access to the A5 North Wales Expressway.

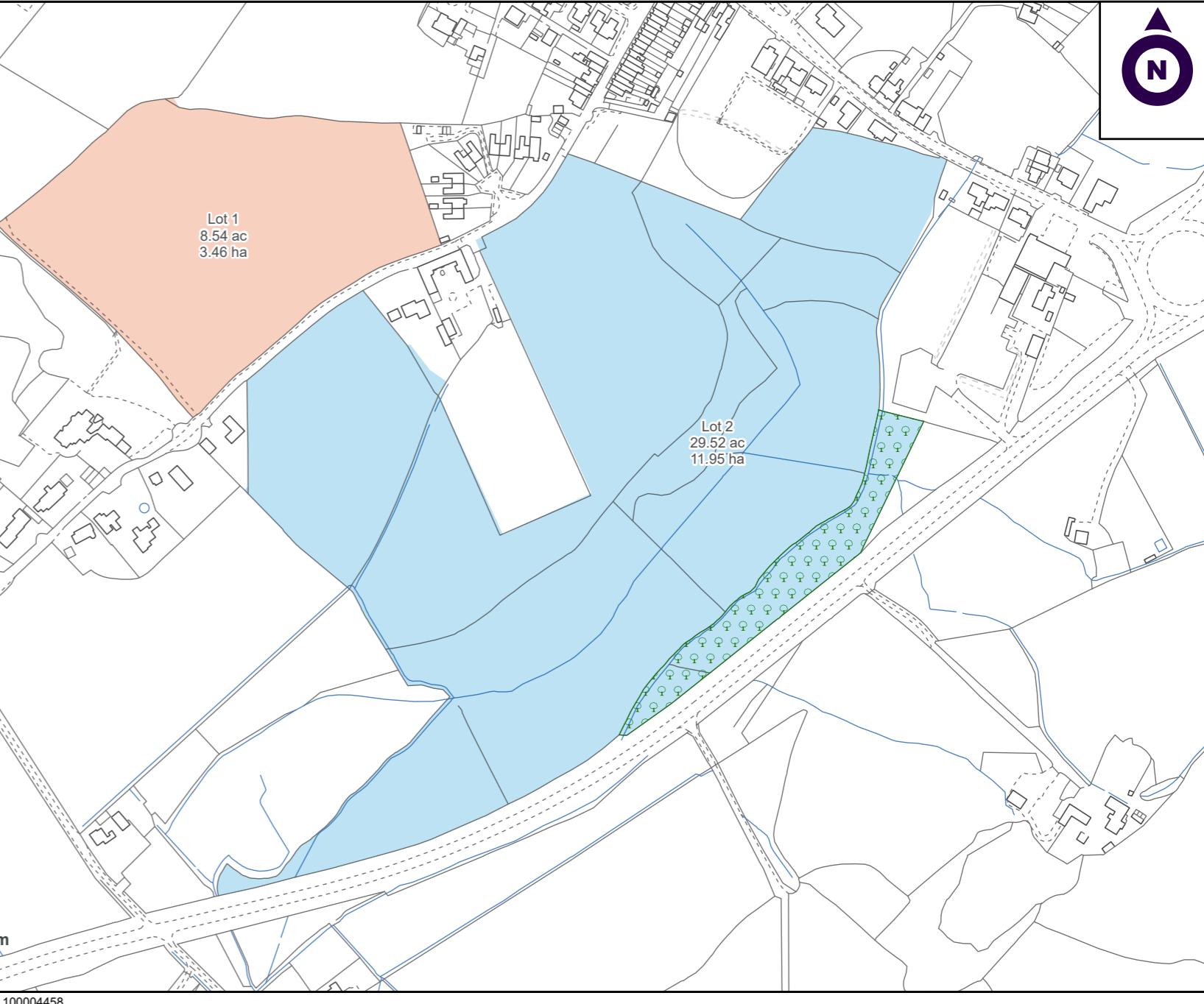
**Land**

The land is comprised of approximately 38.0 acres of predominantly productive grassland along with some grazing pasture and woodland cover.

Lot 1 is a ring-fenced block of improved grassland extending to 8.4 acres which is all level and suitable for modern agricultural machinery. The land has benefited from regular reseeding and is well suited for silage and arable crops.

Lot 2 is also ring-fenced, extending to 29.5 acres in total. The land is arranged into three large fields suitable for cropping and grazing which are accessed directly from the public highway. There is further pasture suitable for sheep and cattle grazing, with a block of woodland extending to 1.6 acres.

The farmland is fully stocked and benefits from a natural water supply.



## Method of sale

Lot 1 for sale by private treaty. Lot 2 is under offer.

Freehold with vacant possession.

## Basic Payment Scheme

The farmland is registered with Rural Payments Wales.

## Overage

The property is to be sold subject to an overage clause which states that for 30 years, should a change of use be implemented resulting in an uplift in value, the vendor would be eligible for 30% of that uplift.
