

OBJECTIVE

Over the course of our history, charity: water has funded over 21,000 water projects that will provide more than 6.4 million people with access to clean, safe drinking water.

As we develop strategies to ensure sustainable water projects to keep water flowing, we aim to track those projects with a permanent, physical marker that can confirm each water point's identity – **Water Point Identification**.

In line with this objective:

- 1. charity: water requires that partners who receive 2017 funding will affix *Water Point Identification* to each water point meeting the guidelines stipulated below.
- 2. Partners will be required to budget, procure, and locally source physical *Water Point Identification* for each water point.

REQUIREMENTS

MATERIAL


- Water Point Identification must be permanent.
- Aim for robust materials and print that will last as long as practicably possible.
 - Recommended: engraved metal or marble plaques
 - Not recommended: paint, stickers, or signboards
 - Note: Signboards are acceptable as secondary Water Point Identification, for example: community signs indicating or acknowledging partner activities.
- The Water Point Identification must be large enough to display the required information while still ensuring permanence.

PLACEMENT

• Water Point Identification must be affixed onto the water point as specified below:

INVENTORY TYPE	PRIMARY PLACEMENT	SECONDARY PLACEMENT

CONTENT

- Water Point Identification content includes the following:
 - Water Point ID
 - o charity: water name and/or logo
 - partner name and/or logo
 - o community name and water point name, if required

NOTE

- 1. Water Point Identification MUST be in English and will be verified against the submitted Water Points List at completion.
- 2. Additional information can be in the local language and must be on the secondary identification. examples: depth of well, date of installation, etc.
- 3. charity: water Donor Recognition text is no longer required, unless indicated by charity: water during proposal review.

WHAT IS A WATER POINT ID?

- charity: water classifies each grant with a unique grant ID, for example: 190. Once your
 proposal is approved, you will use your unique grant ID to assign each water point with a
 Water Point ID.
 - For example, if you've proposed 64 water points under grant 190, the Water Point IDs available to you are **190.001 to 190.064**.
 - You have the flexibility to assign these IDs to water points as you wish, possibly as you complete them or group them geographically within districts.


WATER POINT ID MANAGEMENT

- Only use one Water Point ID per water point.
 - Exception: when a community receives HH interventions such as BioSand Filters or rainwater harvesting tanks, the community is only assigned one Water Point ID and each intervention does not receive its own Water Point ID.
 - Please note that depending on the individual program, charity: water may request household-level water point tracking for HH interventions.
- The Water Point ID can't be used twice or duplicated.
- The Water Point IDs cannot be skipped or deleted without charity: water permission.
- Throughout implementation and completion, the Water Point ID is associated to:
 - the physical Water Point Identification at the site
 - that water point's data on the Water Points List
 - o the photo submission in Box

Effective for grants with a start date of August 1, 2017 or after



• In the event of:

- Additional water points:
 - You can utilize the next Water Point IDs in the sequence; in this example of 64 water points -- starting with 190.065.
- Replacement water points:
 - When you're unable to complete the water point at the proposed site due to extenuating circumstances such as water table issues, natural disaster, seasonality, etc., assign the Water Point ID to the replacement water point.
 - You will then associate the replacement water point's data and photos to that Water Point ID in the Water Point Identification, the completed Water Points List, and the completed photos in Box.

TIMELINE & COMMUNICATION

- During the proposal review phase, stipulate what materials you're using to justify the costs provided in the budget.
- Before actual manufacturing of Water Point Identification, send charity: water a mock-up of the Water Point Identification for approval.
