



## **GIVEAWAY RULES – Grand Ole Giveaway**

June 2, 2024 – June 14, 2024

### **Entry**

Sweepstakes begins the 2<sup>nd</sup> of June 2024 and runs through June 14<sup>th</sup> 2024. Participants can register to win using the designated entry form provided at <https://www.cvgairport.com/grand-ole-giveaway>.

If any chosen entrant is determined to be ineligible or cannot be reached within 48 hours of the initial contact, the Prize (as defined below) will be forfeited, and another entrant's name will be chosen at random. Multiple or duplicate entries will be disqualified.

### **Eligibility**

To be eligible individuals must be legal residents of the contiguous United States and 18 years of age or older at the time of entry. Only one entry per person will be accepted. The following individuals are not eligible to participate or receive prizes: employees, officers, directors and immediate family members of the CVG Airport Authority (the "Sponsor") and any airline associated with CVG. This includes any spouse, parent, child, sibling, grandparents/children, step siblings/children, and in-laws or their respective spouses, regardless of where they reside, or member of the same household, whether or not related. Individuals who meet the requirements described above are Eligible Entrants.

Odds of winning depend on the number of Eligible Entrants. This sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the United States and where prohibited or restricted by law, rule, or regulation.

Sponsor is not responsible for entries that are not received for any reason, or for entries that are received but are not decipherable for any reason. Sponsor will automatically disqualify any submission from a non-eligible individual and any incomplete or illegible entry.

There is one prize: a Southwest Airlines flight voucher for five-hundred dollars provided by CVG Airport, a 2-night stay at the Drury Plaza Hotel Nashville Downtown, and a VIP Star Card - Attraction Pass in conjunction with Nashville Convention & Visitors Corp. Sponsor will award the prize through random selection among the pool of Eligible Entrants. The winner will be announced within 2 weeks of June 14<sup>th</sup>, 2024.

Prizes are non-transferable, non-assignable, and not redeemable for cash. The Sponsor reserves the right to substitute the Prize for another prize of equal or greater value. No purchase is necessary to win a prize. Winner agrees to all terms on the airline vouchers as a condition of receipt of a prize.

Each winner is fully responsible for any and all applicable federal, state and local taxes and fees/charges (including income and withholding taxes). All costs and expenses associated with prize acceptance and use not specified herein are the sole responsibility of the winner. The winner must agree to comply with



all terms and conditions on the prize voucher and all applicable laws and regulations in connection with each prize.

### **Notification**

Sweepstakes entrants agree to email communications from CVG Airport Authority and airlines associated with CVG. Entrants are free to opt out at any time. Their contact information will not be shared with any other parties.

The winner must, within 24 hours of receipt of prize notification, provide Sponsor with all eligibility information, i.e., proof of age and U.S. residency, as well as photographs of the winner for publication by the Sponsor. In the event the winner is unreachable for any reason, the Sponsor may select an alternate winner. In the event any alternate winner fails to respond to any such prize notification, the alternate will be disqualified, and the prize will be forfeited, at the Sponsor's sole discretion. Failure to timely submit required documentation as described will result in disqualification and forfeiture of the Prize. By participating in the sweepstakes, entrants agree to Sponsor's collection and usage of their personal information and acknowledge that they have read and accepted Sponsor's privacy policy. In addition, the Sponsor may share entrants' information, including email addresses, with airlines associated with CVG.

### **Conditions**

By participating in the sweepstakes, each entrant agrees that the Released Parties are not responsible for stolen, late, incomplete, inaccurate, misdirected, lost, damaged, delayed or garbled entries, regardless of cause or reason. Persons who tamper with or abuse any aspect of the sweepstakes or attempt to



undermine the legitimate operation of the sweepstakes by cheating, deception or other unfair playing practices, or intend to annoy, abuse, threaten or harass any other entrant or Sponsor's representatives will be disqualified and all associated entries will be void. The Sponsor has the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Contest, and to resolve all disputes in the Sponsor's sole discretion.

In any such dispute, the party bringing the suit shall be entitled only to its actual damages, and shall not be entitled, under any circumstances, to any punitive, incidental, or consequential damages, or any other damages, including attorney's fees and costs.

The Sponsor reserves the right, in its sole discretion, to amend, modify, cancel or suspend the sweepstakes (or any portion thereof) for any reason.
