# **ENTRIES**

Entries can be completed online at <a href="www.horseshowoffice.com">www.horseshowoffice.com</a> or sent via USPS. No entries accepted by phone. Payment is due with entries. Online entries must be submitted on the OPENING date of March 10, 2023, or thereafter, up to and including the CLOSING date of April 12, 2023. Post entries will be accepted within the ability of the show to accommodate additional entries. Mailed entries must be postmarked on or after the OPENING date of March 10 and must be RECEIVED by the Show Secretary by April 10. Mailed entries not received by the mailed closing date of April 10 are subject to post-entry fees and may not be accepted if received too late. Credit cards are accepted at <a href="LEC">LEC</a> Horse Show Competitor Payments for entries. Please use the entry blank provided in this prize list if entering by mail and make copies for additional entries. If oversubscribed, entries will be placed on a waitlist.

Friday High Team and Freestyle classes will be scheduled from 4:00 pm until approximately 8:00 pm. Saturday and Sunday rides may be scheduled from early morning through evening. Should scratches occur the day of competition, post entries will be accepted for those times. The Show Committee reserves the right to limit entries or classes per horse, to add, divide, or cancel classes, or make whatever changes are required by the circumstances of the competition. The RIDER, OWNER, TRAINER, and COACH (if applicable) must sign each entry.

## **RULES AND REGULATIONS**

**Safe Sport:** Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. **Force Majeure**: In the event of a force majeure, this competition may be subject to cancellation. "Force majeure" shall mean fire, earthquake, flood, snow, ice, lightning, act of God, or the presence of contagious or infectious disease among humans (for example but not limited to Covid-19) or animals (for example but not limited to EHV 1/4 or strangles), work stoppages or other labor disturbances, riots or civil commotions, litigation, war or other act of foreign nation, power of government, or governmental agency or authority, or any other cause like or unlike any cause above mentioned which is beyond the control of the show management. In the event of cancellation before the show begins due to force majeure, all fees paid by competitors will be refunded.

**Stabling and Tack**: Bedding not provided - bagged shavings available for purchase. Please pre-order any shavings needed. Permanent box stalls and vinyl temporary stalls with doors (all are minimum size 10 X 10), both under roof. Stallions, horses over 17 hands and entries showing for entire weekend will be given preference for permanent stalls. Weekend stabling will have preference over day stall or overnight stabling. **Team entries will have preference for tack stalls if limited.** Due to the limited number of stalls available, we may be unable to honor all requests for non-competing horses or tack stalls. Please direct all stabling questions to the show secretary Anne Sushko at (563) 580-0510 or <a href="maintenance-gandasushko@hotmail.com">gandasushko@hotmail.com</a>. Stabling opens Thursday at 9:00 am. Numbers must be worn whenever a horse is out of its stall. NO SMOKING near barns. Smoking is permitted only in your personal vehicles in the parking lots.

**Refunds**: If an entry is canceled before the closing date, all fees are refunded minus the office fee. After the closing date, the USEF fee and qualifying fees and/or any nonmember fees, if paid, are refunded. No refunds for filled scratches. No refunds for stabling. Waitlist exhibitors contacted for openings and accepted are fully responsible financially to the show. No other fees are refundable after the closing date for any reason, including in the event of cancellation of classes due to severe weather or other emergencies. We do request that all cancellations be called in so that adjustments may be made to the schedule.

**No Shows**: All "no shows" who have not contacted the show office prior to their first ride will be considered a scratch/elimination for the rest of the weekend, are subject to the USEF fee, and their time slots will be filled.

Confirmation/Ride Times: Rides may be scheduled from early morning through evening each day. Confirmation of entry will be emailed. All email addresses must be clearly printed and legible. Provisional ride times and show updates will be emailed to competitors and will be posted at <a href="https://horseshowoffice.com">horseshowoffice.com</a> on Wednesday before the show. Official times will be posted at the show office by noon Friday. It is the responsibility of the rider to inform the show secretary of any time conflicts as soon as possible after receiving provisional ride times.

**Proof of membership**: If entering the show electronically, USEF and USDF registration is verified electronically if valid and correct membership numbers are provided on the entry form. Copies of USEF and USDF memberships, horse recordings or HIDs must be included with your entry if it is mailed.

**Coggins**: A negative Coggins (EIA) Report listing horse's recorded show name within one year of show dates is required for all horses on grounds. Show number and stabling will not be assigned without negative Coggins.

**Vaccinations**: As per GR844 Equine Vaccination Rule, competitors must have vaccination records for their horses available for inspection. Lake Erie College horse show management reserves the right to require that all competitors show their proof of vaccinations at check-in for licensed competitions at the George M. Humphrey Equestrian Center. Should current local equine health circumstances require extra vigilance on the part of horse show management, you may be asked to show proof of the required USEF vaccinations at check-in.

**Breed Awards**: High Point Breed awards will be given to horses registered in USDF All Breed Participating Organizations and other breed awards if available. Competitors must bring copies of proof of their enrollment in their specific breed organization to the show. If a horse has multiple breed registrations, the competitor must choose which breed award s/he wishes for consideration.

**Opportunity Classes** are meant for entry-level riders wishing to participate in a recognized show experience but who do not wish to participate in USEF/USDF awards programs. Riders entering only Opportunity classes need not pay the USEF fee, USEF/USDF non-member fees or USDF HID fee. If riders also enter the USDF Introductory classes, then the USEF fee must be paid. Cross-entering into other regular classes requires payment of all missing USEF/USDF non-member and USDF HID fees. Scores from Opportunity classes are sent to the USEF and USDF but are not recorded or counted for their year-end awards. Riders in opportunity classes may compete wearing breeches and shirts (with sleeves and collars) of any color as permitted in DR120.8. Jackets are not required. Boots and protective headgear are required as specified in DR120.1-6.

**Pony Measurement**: Ponies entered in FEI Pony Tests in need of USEF measurement cards must make an appointment for measuring with show management prior to the show. The official measurement session will be scheduled for 9:00 am on Saturday morning or as arranged by show management. Owners of ponies needing measurement will be charged a fee not to exceed \$100 to cover the fee charged by the official veterinarian required for the measurement.

**Dressage Seat Equitation**: will be run as a group class. The purpose of the Dressage Seat Medal Program is to promote and reward correct seat, position and use of aids in dressage. For more information about this program, check DR133

**Adult Amateur Equitation**: Will be run as a group class. The purpose of the Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. For more information about this program, check DR133.

Freestyle Classes: Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior, FEI Young Rider and FEI Para-Equestrian Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels and 60% for FEI levels in the highest test of the declared freestyle level or any test of a higher level at a USEF/USDF licensed Dressage Competition, Federation Licensed or FEI recognized Dressage Competition, or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. CDs must be clearly labeled with entry number and music directives, delivered to the show office two hours before the class starts, and picked up following the class. Unclaimed CDs will not be mailed. You may designate an assistant to direct the playing of your music. Sound tests may be scheduled Thursday 12:00 pm— 6:00 pm and Friday from 10 am — 3:00 pm or Saturday at 7:00 am or during the lunch break. Management recommends that you bring TWO CDs as we have had occasional problems with the first CD and have used the backup.

**Awards**: Ribbons to 6 places. Divisions: (JR/AA/Open) may be run concurrently as one class. Divisions will be pinned separately. No separate awards for GAIG Qualifying classes. Champion and Reserve Champion High Point ribbons will be awarded to the top two high-score entries in 1) Open and 2) Combined AA-JR/YR divisions at each of the following three levels:

- Training through 2nd Level
- 3rd and 4th Level
- PSG, Intermediate I and all FEI/TOC

Intro, Opportunity, Freestyle, Young Horse, Equitation, Paraequestrian and Materiale classes do not count for the championships.

**Arena**: Dirt/sand footing. Standard-size dressage arena set inside 100' x 250' side walled Main indoor arena. Smaller attached indoor warm-up 70' x 120'. Inspiration Arena: 238' x 76' side-walled indoor arena with dirt/sand footing. Intro through Training 2 may be in a small dressage arena (20 m x 40 m). Intro through Training 2 may be in the Inspiration Arena only if the show is heavily oversubscribed and entries necessitate adding this additional competition arena. Training 3 and higher will be in a large competition ring in the Main arena (20 m x 60 m). Standard-size dressage arena (20 m x 60 m) may be set inside 100' x 250' fenced-in outdoor arena (limestone footing) for warm-up, weather permitting.

**Footing**: Preparation and consulting for indoor (dirt/sand) and outdoor (limestone) arenas at Lake Erie College provided by Lake Erie College.

# **Schooling in the Main Competition Arena:**

Thursday from 4 pm - 8 pm.

Friday from 10:00 am through 3:30 pm.

Friday and Saturday for 30 to 60 minutes after last class.

# **Schooling in the Inspiration Arena:**

Friday, Saturday, and Sunday 7:00 am throughout the show each day.

<u>Lunging</u> is allowed only in designated lunging areas. If bad weather exists, then lunging will be scheduled for indoor areas and times will be posted in the show office. Mounted schooling is never permitted in the same area as lunging.





# **Management Rules and Procedures:**

- NO PARKING BY BUILDINGS. NO PARKING BY BARNS OR MANURE PIT AREA. Trailer and vehicle parking in designated areas only. Violators may be towed at owner's expense.
- Show Management reserves the right to vary or add officials, to refuse any entry of any exhibitor for
  cause, to disqualify any exhibitor and/or his horse for cause, to cause an exhibitor to forfeit his winnings
  and ribbons for cause, to have horses removed from the grounds for cause, and to return any entry
  and/or stall fee before or during the show for cause, all without being liable for damage or
  compensation.
- Show management reserves the right to make any changes deemed necessary for the safe an efficient conduct of this competition.
- Management reserves the right to combine or cancel classes, to vary or add officials, and to refuse entry of any exhibitor for cause.
- Dogs, except for service animals, are not allowed in the main lobby of the Learning Center. All dogs at the equestrian center must be on a leash no longer than 6' and held by a responsible adult/fixed object at all times.
- Bridle numbers must be worn by the horse at all times when out of the stall.
- No smoking in lobby, barns or arenas. Smoking is ONLY permitted in your personal vehicle in parking lots.
- Lake Erie College and its employees will not be held responsible for loss or damage to persons, property or horses.

### **Facilities:**

- FREE Wi-Fi, restrooms and showers available in the Learning Center. Motor home or trailer electricity is NOT available.
- Concessions: Open according to the requirements for a Level 2 show and conforming to current COVID restrictions. Hours posted in show office on official show board. Bottled water available for purchase at concession stand during posted hours as per COVID requirements.
- Medical and Sharps Waste: Sharps containers are located in each barn in the following locations: wash rack in the boarder barn, temp stall area by south door (door facing arena) and in the middle aisle of school barn outside wash racks. Per USEF rules, competition management may fine any individuals, including trainers, owners, exhibitors, and their agents, up to \$100 for improper disposal of needles or other sharp disposable instruments.



# PRIX DE VILLES DRESSAGE TEAM COMPETITION RULES





Opportunity classes for their team tests. Adult Amateurs must have a USEF Amateur card unless they are only entered in Opportunity classes. Teams consist of 3or 4 entries with the 3 highest scores per day to count. Horse/Rider team entries may not have competed at previous recognized shows more than one level above their team rides. Horses may only show on one team. In the Low Division, two riders maximum may show at each level. In the High Division, only one rider may show at FirstLevel. Any combination of levels (but no more than two riders at any one level) is acceptable for the other team riders. **All team members must ride BOTH TEAM TESTS** at their chosen level. The combined scores for the 2 days will be the final team score. Highest team score wins. In case of ties, the highest single score of a non-professional on the team will decide. No substitution of horse or rider after the first team test. **At no time while on the show grounds may any horse entered in the team competition be ridden by anyone other than the rider entered in the team competition.** Exception: grooms riding on a loose rein.

FEI Tests Riders may do the same test both Friday and Saturday or a different test each day as long as they are consecutive levels(i.e. PSG/PSG or PSG I-1).

<u>Individual Championships.</u> Adult Amateur, Junior/Young Rider, and Opportunity rider team members are eligible for the Low or High Individual Prix de Villes Championships <u>(no professionals).</u> The Individual Prix de Villes Champions for the Low and the High Divisions will be the horse/rider entry with the highest combined average score based on their 2 team rides. Ties for the Individual Championships will be broken by the single highest score earned on a team ride.

**NEW!!!** Awards Presentation: A formal awards ceremony will be held for all teams.

- **▶** High Team Awards will be presented at lunchtime on Saturday.
- **Low Team Awards will be presented at lunch time on Sunday.**

The top 3 teams in each division are required to participate on foot in show attire. **Note:** Prize money will be mailed to person indicated on the team's entry form within 30 days from the end of the competition. All W-9 forms must be completed and returned to the show secretary at the show for distribution of prize money.

# GR844 Equine Vaccination Rule (© USEF 2023)

- 1. At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.
- 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration.
- 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration.
- 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested.
- 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee.

## Rationale for GR844

Over the last 7-8 years there have been several high-profile Equine Herpes (EHV) outbreaks that have involved the neuropathic strain of the virus (equine herpesvirus myeloeocephalopathy-EHM). Influenza outbreaks don't get nearly the same attention as EHV /EHM but they do occur.

The American Association of Equine Practitioners (AAEP) publishes vaccination guidelines that are reviewed by infectious disease experts every few years. The current guidelines recommend vaccinating competition horses at 6-month intervals for both equine influenza (Flu) and rhinopneumonitis (EHV-1 and EHV-4). It is important to point out that no vaccine protects against the paralytic neurologic disease (EHM), but the intent of vaccination is to reduce the spreading of virus which will hopefully minimize outbreaks in which EHM is manifested.

In many parts of the world the vaccination of horses is covered by national law. The FEI has a requirement for all horses to be vaccinated for influenza within the previous six months. The new USEF vaccination rule is General Rule 845 and will go into effect 12/1/15. This rule is consistent with the AAEP recommendation.

This rule change does not anticipate an increase of work for competition management. Most competitions, when horses are being checked in, require a health certificate and a negative Coggins test. The flu vaccination information can be added to either document. The requirements of this rule have not been made to be onerous on any group. However, it is important to point out that the responsibility lies with the competitor to provide documentation if requested by Competition Management. It is not a requirement that every competition verifies such documentation. If vaccination documentation will be reviewed upon arrival at a competition, it is recommended that this be published in the prize list.

If Competition Management chooses to verify the required documentation, any competitor that fails to provide the appropriate documentation of vaccination pursuant to the new rule may be asked to remove the horse from the grounds. If further clarification is necessary, please contact the Equine Drugs and Medications office at 800-633-2472.



# Equine Biosecurity Recommendations for your horse's health and safety

Lake Erie College is committed to the health and safety of our resident school horses and all of our visiting competition horses. To encourage everyone on the premises to use good practices and health safety measures to protect our horses, please observe the following suggestions:

## At the Show

Wash and disinfect your hands frequently!

Do not handle or pet horses other than your own.

Do not let your horse touch other horses, particularly nose-to-nose.

Do not share water buckets, feed tubs, tack or other equipment between horses.

You may elect to take temperatures on your horses twice daily. Report all temperatures over 102.0°F directly to the Show Manager.

# **Going Home**

Clean and disinfect your tack, boots, equipment and grooming supplies.

When you get home, shower, blow your nose and put on clean clothes and shoes before going near other horses at home.

# **ATTENTION COMPETITORS**

USEF rule DR 120.6 requires that PROTECTIVE HEADGEAR meeting or exceeding ASTM/SEI standards forequestrian use <u>be worn at all times by anyone mounted on a horse on the competition grounds.</u>

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

# **Motorized Vehicle Statement 2023**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

# **Membership Statement 2023**

Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

# ACTION PLAN FOR PARENTS AND TRAINERS

If you suspect that an athlete has a concussion, you should take the following steps:

- 1. Remove the athlete from the horse; do not allow him/her to remount.
- 2. Ensure athlete is evaluated by an appropriate health care professional. Do not try to judge the seriousness of the injury yourself.
- 3. Allow athlete to return to practice/competition only with permission from the appropriate health care professional.

Athletes competing in USEF competitions should refer to General Rule 1316 for the USEF rules on returning to competition.

## 2023 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at <a href="www.usdf.org">www.usdf.org</a>. Please refer to the 2023 USDF Member Guide for the comprehensive list of rules and requirements for this program.

# Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

### Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Active or Life).

### Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).
   A horse is not required to have breed registry papers.

### Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF.
   For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.
- \* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division.

# **USDF** Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

# **Qualifying Requirements**

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

 Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

### or

b) Qualified to compete in any regional dressage championship class (excluding freestyles).

# **Membership Requirements**

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

The USDF Regional Adult Amateur Equitation Program rules and information can be found on the USDF website.

<u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions:

Owners and riders, including foreign riders

and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

### **Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
  sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
  Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
  exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
  academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
  identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

# **Memberships Defined**

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. **Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:
