Adjustment in Neles due to merger with Valmet

The Boards of Directors of Neles Corporation (Neles) and Valmet Oyj (Valmet) have agreed upon the combination of the two companies through a merger whereas shareholders of Neles will receive 0.3277 new shares in Valmet for every one (1) share held in Neles. The merger plan was approved at the Extraordinary General Meeting (EGM) held on September 22, 2021. The Ex-date is April 1, 2022. Nasdaq Derivatives Markets has carried out a re-calculation and changed the ticker code, underlying issuer and underlying ISIN for regular and gross return forwards in Neles (NELES).

New regular and gross forward prices have been rounded off to three decimal places and received an "X" or "Y" in the series designation. As a result of the adjustment the number of shares per contract has decreased to 33, after rounding to the nearest full share. The regular and gross forward prices have increased. The rounding off of regular and gross forward prices was made "trade by trade" and not on



the net position. The underlying share has received a new ISIN-code and new symbol. The series received new names, ISIN-codes, contract sizes and product IDs, which can be found below.
