# **REPORT FROM THE CHAIR**

Golf in Tasmania is in good shape: its foundations are solid, with membership numbers over the 67 clubs growing 6% in 2024 to almost 12,800. This is a strong result coming on the back of a 5% growth in 2023. It is pleasing to see strong growth in junior numbers, increasing by over 50% from 537 to 820. There seems to be a keen interest in golf, particularly among young males, which appears to be driving this growth. Juniors now make up 6% of all members of clubs, and this is a strong endorsement of the programs being conducted by Simon Weston and the team under the Golf Australia (GA) banner.

Somewhat disappointing is that female numbers overall have remained relatively static, despite programs aimed at encouraging participation. However, there are encouraging signs for improvements at the junior level in Tasmania with girls making up 43% of MyGolf participants, so watch this space.

So where to for golf in Tasmania?

Despite a year of solid growth in membership numbers, golf in Tasmania shares the national challenge. While golf nationally is seeking to cast off the image that it is a sport for rich people, rising demand for on-course golf may reach a point where membership numbers need to be managed either through membership caps or higher membership fees.

While nationally, golf faces challenges of how to service a growing demand with a fixed supply of courses, the situation in Tasmania differs somewhat.

Tasmania has seen considerable investment in new/renewed golf facilities, with two more expected to come online in 2025. These investments are aimed at serving the luxury end of the market, free of the obligations to serve a membership base. By 2025 there will be 15 18-hole golf courses, five of which derive their income purely from green fees.

Given a social golfer can obtain a handicap without the need to join a club, there is little imperative to do so. Member-based clubs, whose income is underpinned by a strong membership base supplemented by green fees, will face more competition for the social golfer's dollar. Social golfers will have greater choice as to where and when they play, and clubs may need to examine their business models moving forward, balancing the rights of members to have access to their course versus the need to give social players access in order to compete with the non-member clubs.

Of more pressing concern to Tasmanian golf clubs is financial viability, and in the case of courses with ageing and declining memberships, manpower constraints. Golf Tasmania (GT) is working with GA to address some of these challenges including the increasing burden of insurance and pressure from local councils hungry for rates. Improved support services through the online portals is an important area and GA will be rolling out a new platform in 2025 that will streamline management of competitions and member services.

GT is working with GA golf participation programs have shown continued growth: MyGolf had 1,518 registrations in Tasmania. The number of Community Instructors has increased to 87 with another 8 signed up but yet to complete accreditation. Having a team of Community Instructors is critical to being able to maintain school programs. Get into Golf had 868 registrations, including 698 females and had 23 active centres across Tasmania. Congratulations to all those involved as it all goes well for the continued growth.

The Australian Golf Foundation provided scholarships to 9 clubs with 66 girls involved in the program around the state. Golf Tasmania (GT) contributed \$13,259 to assist in funding this program. This is a great foundation to increasing female participation and hopefully sustaining it in the future.



# **REPORT FROM THE CHAIR**

With 125 signatories to the R&A Women in Golf Charter in Australia, Tasmania has punched above its weight in having 21 clubs signed up with several more clubs looking to sign. Congratulations and thanks to all involved.

This year has been the first under the State Services Agreement with GA, which was concluded following a review of the initial One Golf agreement. The new agreement is more focussed on specific Tasmanian needs and aligns our strategic plan with the Australian Golf Strategy via a Balanced Scorecard. This links the activities of GT to those of the strategy in a measurable and accountable way.

During the year the Board conducted a review of the GT constitution to "tidy up" the rules around our operations.

A number of key deliverables were concluded in the past year. A highlight was the 2024 Men's and Women's Tasmanian Open and Inclusive Championship, held once again at the Launceston Golf Club. Congratulations to the winners and all the participants, and thank you to the Launceston Golf Club for their support and efforts in conducting a successful event.

Appreciation and gratitude is also extended to the Tasmanian Government for its continued sponsorship for the Men's and Women's Tasmanian Open this year and 2025. Our appreciation extends to the Launceston City Council which also provided sponsorship for 2024.

The Board of Golf Tasmania considers it important that the state continue to host this adidas PGA Pro-Am Series event. It is vital for the growth of the game in that it provides opportunities for our golfers, both amateur and professional, to aspire and participate in events of this calibre.

Unfortunately, we were again unable to field a girls' team in the Junior Interstate Teams Matches, but the boys performed admirably. The Men's and Women's Interstate Teams Matches held in Queensland saw our teams enjoy some success. Well done to those who participated and also to the support staff and organisers. Congratulations are extended to winners of State events and competitors.

Participation in state events has seen competitor numbers continue to decline. GA, through its venue acquisition project, and GT's Tournament, Rules and Ratings Committee are continually reviewing and striving to evolve events to attract participation. Events are important for the future growth of golf in Tasmania in that they provide a pathway and opportunity for golfers to compete alongside their peers. Clubs should take into consideration the future of Tasmanian golf when contemplating hosting state tournaments.

The High Performance program has occupied the thoughts of board members wishing to ensure that programs and pathways are well documented and transparent, including the flow through to State representation.

Achieving ongoing growth, interest and participation could not be achieved without the members, clubs, district associations and the volunteers involved in running club, district and state events. We thank them for their continued commitment and support.

I would particularly like to acknowledge the contributions made by the TRR committee members for its valuable input for competition policy as well as practical support in rules officiating.

We are thankful to have GA staff members Stuart Eaton, Simon Weston and Damon Burley who deliver high quality services which are responsible for the increased growth in participation and golf development. They are very much appreciated by the GT Board and the golfing community. Already we can see the positive impacts their work is having on golf in Tasmania, particularly in the areas of junior and girls golf.

I would also like to acknowledge the contribution by David Stein (GT/Vic State Manager) who is moving to a new position within GA, and wish him well, and I welcome on board his replacement, Rohan O'Neill. Thanks also to David Greenhill (Head of Governance and Operations) for his continued support for golf in Tasmania.

In closing, I acknowledge my fellow Directors and thank them for their positive contributions to the administration of golf in Tasmania. To Bev Holman, who retires this year after 9 years' service, and Alison Sully who steps down to become Captain of Royal Hobart, your contributions will be missed. Continuing Directors, Fleur King, Neil Randle and Peter Volker, thank you for making an important and significant contribution to the growth of golf in Tasmania.

And finally, and on behalf of the Board, thanks to the golf clubs of Tasmania whose support is vital for GT to perform its role on behalf of the state's golfers.

# **TREASURER'S REPORT**

For the period 1 July 2023 to 30 June 2024, Golf Tasmania Incorporated (GT) recorded a profit of \$33,308 (2023 loss of \$3,904). The key components of this positive result include \$41,800 in rental income and interest received amounting to \$17,944.

In addition, GT donated \$13,259 to the Australian Golf Foundation to support the Junior Girls Scholarship Program. The funds for this donation are collected as part of the affiliation fees paid by Tasmanian golfers. An extra \$1.00 is added to the affiliation fee to support this important initiative. Tasmania had 9 golf clubs with 11 scholarships and 68 girls participate in this program. Each club received \$2,100 plus GST to be used only for 24 weeks of professional lessons.

Also, GT supported prizes for the TeeMates competitions amounting to \$2,500 for the financial year. Again, this support was seen as an important initiative to support Tasmanian junior golfers.

In the year 2024, \$462,231 was collected in affiliation fees compared to \$403,220 last financial year, which is then provided to Golf Australia Limited (GA) per the service agreement in place.

In 2023, GT entered into a new agreement (the "Australian Golf State Services Agreement") with GA pursuant to which the parties agreed that GA will provide particular member services, as specified in the Australian Golf State Services Agreements, for the benefit of GT and the members.

# **HIGH PERFORMANCE REPORT**

Throughout the year, we have coordinated various activities for our High-Performance athletes, focusing on skill development, competitive preparedness and holistic support.

### Camps

We conducted several camps around key Tasmanian events, creating a supportive environment for our squad to develop skills. Each camp emphasized a particular aspect of the game, with key focuses including:

- Short game
- Putting
- Wedge play
- Bunkers
- Nutrition
- Psychology
- Scheduling

**Key Locations** 

- Tasmania and Royal Hobart Golf Clubs: These clubs graciously hosted multiple weekend camps, providing excellent facilities for our training needs.
- North Tasmanian Amateur Prep Camp (Launceston and Riverside GCs): This camp provided individual training with Richard Cooney and focused on preparation for the Tasmanian Amateur in November. We also engaged with the TIS facility in Launceston, adding valuable support from TIS staff.

### Tasmania Institute of Sport (TIS)

Our relationship with TIS remains strong, with regular use of their facilities in Hobart and Launceston. Due to school commitments, Hobart-based athletes train once weekly at UniGYM with Brendon Kull and once at TIS under supervised training. TIS has approached us about funding for their services, which we have not provided over the last 18 months. Discussions are ongoing to address this request.



### Targeted Funding

Over the past eight months, we allocated targeted funding to support athletes in various areas, including:

- Event travel outside Tasmania
- Physiotherapy sessions
- Psychological support
- Coach funding
- Club fitting and equipment

### **College Golf**

Maintaining ties with college athletes Hunter Gillard and Mackenzie Wilson remains a priority. We engage regularly with them and their college coaches, providing funding for necessary support when they return home. Richard Cooney's involvement has been instrumental in their development. With Hunter's family relocating to Queensland, supporting him beyond this year may pose challenges.

### RESULTS

### Junior Interstate

**Boys -** Team Members: Edison Lee, Eli Monaghan, James Robinson, Jonty Lunson and Koby Wegman.

The boys put up a great fight across some very close matches, showing a lot of determination and resilience. Overall, results were mixed over the few days, but there were definite highlights, including halving against Queensland with strong wins from Jonty and Eddy. With us winning against Australian capital Territory on the final day, is very motivating for this group.

Scoring 8.5 points/matches is a solid result, providing a good foundation to build on for future competitions.

**Girls** - As the girls were not selected for the interstate series, we created alternative opportunities, including participation in the Australian Junior Championship and a Melbourne trip. Highlights of the Melbourne trip:

- Five days with head coach Richard Cooney and trainer Zoe Parker
- Practice round and three competitions at Northern GC and Victoria GC
- Training at the Australian Golf Centre
- One-on-one coaching and strength and conditioning

# **PARTICIPATION REPORT**

2024 has seen a solid increase in club membership across Tasmania. There are now more than 12,700 total affiliated members including 820 junior members.

For context, there were 10,200 total affiliated members in Tasmania during 2019 with 276 juniors. Participation is up Australia-wide and golf is going through a great period of growth.

3,800,000 Australian adults participated in some form of golf in the last 12 months. This includes 1,300,000 on course only, 1,500,000 off course only and 1,000,000 both on and off course. These numbers are significant and proves that golf is a big sport and its getting bigger.

Australian Golf's philosophy of "all golf is golf" and "all of us can be golfers" is being proved by the above participation numbers.

Get into Golf (adult introductory program) and MyGolf (junior introductory program) both set records in the last 12 months. In Tasmania 43% of the MyGolf participants were girls!

The Australian Golf Foundation (AGF) Junior Girls Scholarship has once again been a great success. 9 clubs offered scholarships to 71 girls in 2024. These girls are now playing on course and some are obtaining handicaps. Retention rates in the AGF scholarship are over 80%. Growing the number of junior girls remains a priority.

TeeMates continues to build momentum. 6 junior events were offered in 2024 in Tasmania across the 3 regions. These events were well supported and many kids and families travelled significant distances to compete.

Youth on Course now has 10 venues in Tasmania. This allows TeeMates members to play unlimited rounds of golf at these selected venues for \$5.00.

The community instructor program has been re-branded as the "National Program Delivered". This is now managed by the Australian PGA. Deliverers can choose to be trained as a Get into Golf, MyGolf or Schools deliverer.

Finally, thank you to all the clubs, facilities, PGA professionals and National Program Deliverers (community instructors) for supporting Golf Australia's participation programs.



### 2024 MEN'S AND WOMEN'S TASMANIAN OPEN CHAMPIONSHIPS

New South Welshman Alex Edge held off a fast finishing Caleb Bovalina to complete a wire-to-wire win at the 2024 Tasmanian Open at Launceston Golf Club.

Just the second professional winner since Darren Cole in 1992, Edge began the final round with a two-stroke lead, a buffer he increased with birdies at each of his opening two holes.



Given he began the day seven strokes off the lead, Bovalina was not expected to be one of Edge's strongest threats yet after turning in 4-under surged into contention with an eagle at the par-5 10th to go 6-under on his round.

He would log three straight birdies from the 15th hole in a bogey-free course record of 9-under 63, one shot shy of Edge's 9-under tournament total.

Bovalina would share second with Kyle Michel (68) as Edge closed out the biggest win of his career with a 3-under 69.

In the Women's Tasmanian Open, Launceston local Jorjah Bailey produced the round of the tournament to complete a five-stroke win.

Surrounded by family and fellow Launceston Golf Club members, Bailey took a stranglehold on the title with three birdies in her opening five holes, going on to post 3-under 70 for a 2-under total.

Sydney's Rebecca Zhao (73) was second at 3-over, three clear of Round 1 leader Matilda Miels (75).

It was a dominant win for Cameron Pollard in the Tasmanian Inclusive Championship, his rounds of 76-78 enough for an 18-shot win from Rod Welsh.

### 2023 MEN'S AND WOMEN'S TASMANIAN AMATEUR CHAMPIONSHIPS

Josh Fuller from The Vintage in New South Wales and Sarah Johnstone from Ulverstone Golf Club won the Tasmanian Amateur Championships for men and women.

Fuller, a previous Tasmanian Open winner and a member of the NSW High Performance squad, defeated Alexander Yap of Links Hope Island in the final, 3&1.

He had taken until the 19th hole to defeat Mitchell Revie of Tambourine Mountain Golf Club in the semi-final earlier in the day.

Meanwhile Johnstone, a past Tasmanian captain, also endured in a titanic final against young Melbourne star Olive Spitty to win the women's championship 2&1.



Medalists in strokeplay were Sophie Hilditch from Royal Adelaide, who won by a single shot from Johnstone, and Victoria's Rupert Toomey, who won a three-man playoff to determine the strokeplay champion.

The championships were contested at Devonport Country Club.

### 2024 TASMANIAN JUNIOR AMATEUR

Queenslanders Mikayla Dyal and Max Russell completed a successful raid from the north at the Tasmanian Junior Amateur in Claremont.

Russell dominated the boys' championship having opened with a stunning 62, adding rounds of 65, 68 and a steady 72 to finish at 9-under par.

Russell was five shots ahead of his nearest challenger, another Queenslander Alfie Ward at 4-under.

Dyal was similarly outstanding in the girls' championship, winning by five shots with scores of 70-72-68-71 for a 7-under total through 72 holes.

She is a previous winner of the NT Classic in 2023. Ionna Muir of Pelican Waters was the next-best at 2-under.

# 1 Summary of material accounting policies

This note provides a list of material accounting policies adopted in the preparation of these financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated. The financial statements are for Golf Tasmania Inc. (the "Association").

#### (a) Basis of preparation

#### (i) Special purpose financial report

In the board of management's opinion, the Association is not a reporting entity because there are no users dependent on general purpose financial reports. This is a special purpose financial report that has been prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 1964 Tasmania and must not be used for any other purpose.

The financial report has been prepared in accordance with the recognition and measurement principles of all applicable Australian Accounting Standards. It contains the disclosures that are considered necessary by the board of management to meet the needs of the members.

#### (ii) Historical cost convention

The financial statements have been prepared on a historical cost basis, unless otherwise stated.

#### (iii) Comparatives

Where necessary, comparative information has been reclassified and repositioned for consistency with current year disclosures.

#### (iv) New and amended standards adopted by the Association

The Association has applied the following standards and amendments for the first time in their annual reporting period commencing 1 July 2023:

- AASB 17 Insurance Contracts
- AASB 2023-2 Amendments to Australian Accounting Standards Definition of Accounting Estimates International Tax Reform - Pillar Two Model Rules [AASB 112]
- AASB 2021-5 Amendments to Australian Accounting Standards Deferred Tax related to Assets and Liabilities arising from a Single Transaction [AASB 112]
- AASB 2021-2 Amendments to Australian Accounting Standards Disclosure of Accounting Policies Definition of Accounting Estimates [AASB 7, AASB 101, AASB 108, AASB 134 & AASB Practice Statement 2]

The amendments listed above did not have any impact on the amounts recognised in prior periods and are not expected to significantly affect the current or future periods.

#### (b) Foreign currency translation

Items included in the financial statements are measured using the currency of the primary economic environment in which the entity operates ('the functional currency').

#### (c) Revenue recognition

Revenue is recognised at the fair value of consideration received or receivable. Amounts disclosed as revenue are net of taxes paid. The following specific recognition criteria must also be met before revenue is recognised:

#### (i) Affiliation fees

Affiliation are recognised as revenue as performance obligations are met and the service is rendered to members throughout the year.

#### (ii) Rental income

Rental income is recognised in profit or loss on a straight-line basis over the term of the lease. Lease incentives granted are recognised as an integral part of the total rental income, over the term of the lease.

### 1 Summary of material accounting policies (continued)

#### (c) Revenue recognition (continued)

#### (iii) Interest income

Interest income is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

#### (d) Income tax

Golf Tasmania Inc. is exempt from income tax under section 50-45 of the Income Tax Assessment Act 1997. Golf Tasmania Inc. assesses and determines its exemption on an annual basis in accordance with relevant legislation.

#### (e) Impairment of non-financial assets

Assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value-in-use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

#### (f) Cash and cash equivalents

For the purpose of presentation in the statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

# (g) Trade receivables

Trade receivables are recognised initially at fair value and subsequently measured at amortised cost, less loss allowance. Trade receivables are due for settlement no more than 30 days from the date of recognition.

#### (h) Contract assets

A contract asset is a right to receive consideration in exchange for services rendered to the customer. Contract assets are recognised to the extent that services have been rendered but not yet invoiced and at an amount that reflects the consideration to which the Association expects to be entitled in exchange for the services rendered.

#### (i) Financial assets and financial liabilities

#### Financial assets

(i) Classification

The Association classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through OCI or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

The Association classifies its financial assets as at amortised cost only if both of the following criteria are met:

- · the asset is held within a business model whose objective is to collect the contractual cash flows, and
- · the contractual terms give rise to cash flows that are solely payments of principal and interest.

#### 1 Summary of material accounting policies (continued)

#### (i) Financial assets and financial liabilities (continued)

The Association's financial assets at amortised cost includes cash and cash equivalents, term deposits, and trade and other receivables. The Association does not have any financial assets measured subsequently at fair value (either through OCI or through profit or loss).

#### (ii) Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade date, being the date on which the Association commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Association has transferred substantially all the risks and rewards of ownership.

#### (iii) Measurement

At initial recognition, the Association measures a financial asset at its fair value.

Subsequently, financial assets at amortised cost are mreasured using the effective interest method. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses) together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the statement of surplus or loss and other comprehensive income.

#### (iv) Impairment

The Association assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Association applies the simplified approach permitted by AASB 9 *Financial Instruments*, which requires expected lifetime losses to be recognised from initial recognition of the receivables, see note 1(g) for further details.

#### Financial liabilities

#### (i) Recognition and derecognition

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs. The Association's financial liabilities include trade and other payables and borrowings.

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of surplus or loss and other comprehensive income.

#### (ii) Measurement

Subsequent to initial recognition financial liabilities are recognised at amortised cost using the effective interest method.

#### Offsetting

Financial assets and financial liabilities are offset and the net amount presented in the Statement of financial position when, and only when, the Association currently has a legally enforceable right to set off the amounts and it intends either to settle them on a net basis or to realise the asset and settle the liability simultaneously.

#### (j) Property, plant and equipment

Property, plant and equipment is initially recognised at cost. Cost includes expenditure that is directly attributable to the acquisition of the items.

### 1 Summary of material accounting policies (continued)

#### (j) Property, plant and equipment (continued)

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Association and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to surplus or deficit during the reporting year in which they are incurred.

Increases in the carrying amounts arising on revaluation of land and buildings are recognised, net of tax, in other comprehensive income and accumulated in reserves in shareholders' equity. To the extent that the increase reverses a decrease previously recognised in profit or loss, the increase is first recognised in profit or loss. Decreases that reverse previous increases of the same asset are first recognised in other comprehensive income to the extent of the remaining surplus attributable to the asset; all other decreases are charged to profit or loss. Each year, the difference between depreciation based on the revalued carrying amount of the asset charged to profit or loss and depreciation based on the asset's original cost, net of tax, is reclassified from the property, plant and equipment revaluation surplus to retained earnings.

Depreciation is calculated using the straight-line and reducing balance method to allocate the cost or revalued amounts of the assets, net of their residual values, over their estimated useful lives, as follows:

Buildings

20 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting year.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (note 1(e)).

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in surplus or deficit. When revalued assets are sold, it is Association policy to transfer any amounts included in other reserves in respect of those assets to retained earnings.

# (k) Trade and other payables

These amounts represent liabilities for goods and services provided to the Association prior to the end of financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months from the reporting date. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

Where trade payables are settled via electronic cash transfer, they are derecognised when the Association has no ability to withdraw, stop or cancel the payment, has lost the practical ability to access the cash as a result of the electronic payment instruction and the risk of a settlement not occurring is insignificant.

### (I) Contract liabilities

A contract liability is the obligation to transfer goods or services to a customer for which the Association has received consideration (or an amount of consideration is due) from the customer. If a customer pays consideration before the Association transfers goods or services to the customer, a contract liability is recognised when the payment is made or the payment is due (whichever is earlier). Contract liabilities are recognised as revenue when the company performs under the contract.

#### (m) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the taxation authority. In this case it is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST receivable from, or payable to, the taxation authority is included with other receivables or payables in the Statement of financial position.

#### 1 Summary of material accounting policies (continued)

### (m) Goods and Services Tax (GST) (continued)

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the taxation authority, are presented as operating cash flows.

# 2 Critical estimates and judgements

The preparation of financial statements requires the use of accounting estimates which, by definition, will seldom equal the actual results. Management also needs to exercise judgement in applying the Association's accounting policies.

#### (a) Significant estimates and judgements

Estimates and judgements are continually evaluated. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.

#### (b) Critical accounting estimates and assumptions

The preparation of financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Association's accounting policies. There are no areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the financial statements.

#### 3 Revenue and other income
