President's Report

The statements and report being considered at the Golf Victoria Annual General Meeting (AGM) on 11 November 2024 cover the full financial year from 1 July, 2023 to 30 June, 2024.

At the November 2023 AGM Cindy McLeish concluded her term due to term limits and Ros Warburton was elected to fill the vacancy. Current director Nikki McClure has indicated her intention to step down from the Golf Victoria board at the forthcoming AGM after five years on the GV board, during which time she has also represented the board on the Australian Golf Centre operations committee. On behalf of the board, I would like to acknowledge Nikki on her contribution to Golf Victoria, and more broadly to golf in Victoria. Thank you to Nikki.

I am pleased to report that once again Victorian club memberships have increased by 3.1%. This includes an impressive increase in junior male members of 28.2% and junior female members of 18.5%. This highlights the importance of the current national strategy emphasising 'All Golf is Golf' with a view to better understanding how participants are attracted to golf and the progression from various versions of the game including mini-golf, simulator golf, or hitting balls on a driving range, public course play to eventually joining a golf club.

Across the golfing landscape we need a full range of participants to enjoy the game in all its forms and share that enjoyment with others, as well as ensuring a steady stream of potential club members. These increases in junior memberships are on the back of significant growth in MyGolf throughout Victoria, with 155 active facilities

throughout the State and the program reaching a new record total of 12,040 participants and significantly 3,285 of these participants were female.

The Vic Open was successfully staged with State Government support in February 2024. The event was once again hosted by 13th Beach Golf Links and we thank the board and members for their commitment to the Vic Open format and for making their golf course available. 2024 saw the continuation of the Vic Inclusive Championships, and the playing of the Australian Wheelchair Championships. We congratulate Cameron Pollard on winning the Vic Inclusive Championship, Steven Lockey on winning the Australian Wheelchair title, and congratulations are extended to 2024 Vic Open winners Ashley Lau and Brett Coletta.

In November 2024, the ISPS Handa Australian Open will return to Victoria, following its successful staging at the Australian Club in Sydney in 2023. The 2024 event will be co-hosted by Kingston Heath Golf Club over four days from November 28 to 1 December, with Victoria Golf Club hosting alternating rounds 1 and 2 on the Thursday and Friday. We thank the respective boards and members of both clubs for making their golf courses available for this event. The national golf open will continue to bring together the national men's and women's Open events, along with the inspiring All Abilities Championship.

May 2024 saw the annual interstate series played at the Southport Golf Club on the Gold Coast. The recently adopted format of four men and four women was maintained, although each team was composed of 10 players, with eight competing in any one match.

This change allowed for the option to rotate and rest players, or in the event of injury or illness replace a player accordingly. The Victorian team was very well led by Head Coach Dan Whyley and Assistant Coach Jenna Hunter.

The Victorian team played fabulous, focussed golf forcing their way into the final where they defeated Queensland six matches to two to win the overall championship. Victoria also won the men's trophy and was runner up in the women's, with Amelia Harris, Jazy Roberts, Connor McDade and Phoenix Campbell all finishing the event undefeated. The full team included Amelia Harris, Jazy Roberts (Co-Captain), Molly McLean, Shanaiah Fernando, Seabil Leong, Phoenix Cambell, Jasper Stubbs, Abel Eduard, Connor McDade (Co-Captain) and Siddharth Nadimpalli.

Sadly, we lost Frank Williams in the past 12-months. Frank, along with David Inglis was the driving force behind the establishment of the Australian Masters, held at the Huntingdale Golf Club for many years.

In October 2023, the late Kitty McEwan and Richard Kirby AO were inducted into the Victorian Golf Hall of Fame in front of nearly 200 people at the Victorian Golf Industry Awards night. Kitty was one of the early, if not the earliest, women golf writers. A talented sportswoman with a particular interest in golf, she was a member at several clubs, including Barwon Heads, Riversdale, where she was club champion in 1933 and Commonwealth, where she was the inaugural women's club champion in 1926. She was also Women's Captain. She started writing on golf for The Radiator in 1937 and then the Sun News- Pictorial in 1938, which she continued – with a break for war service in the Land Army – until she retired in 1966.

Amongst Kitty's legacies she is honoured by the Kitty McEwan Trophy at Barwon Heads and by VicSport's Kitty McEwan Award for the Victorian Female Athlete of the Year.

Richard Kirby AO has an impressive career within the golf industry, spanning over 50 years. A former Victorian Golf Association President he was elected to the VGA council in 1982 and remained for 25 years, ultimately being honoured with VGA life membership in 2007. He was also Victorian delegate to the Australian Golf Union in this period and managed various Victorian teams on interstate trips. Richard was also treasurer, president and vice-president of Spring Valley Golf Club where he was also appointed a life member. He was awarded an Order of Australia for his lifetime contributions to golf.

In a fitting tribute to the late great Bob Shearer and his beloved Southern Golf Club, Bob Shearer has been honoured with a life-size bronze statue outside the Southern Golf Club clubhouse. Bob was a four-time winner of the PGA Tour of Australasia Order of Merit and a stalwart of Victorian golf. Bob, a Victorian Golf Hall of Fame Member, passed away in 2022.

Achieving closer collaboration and cooperation between Golf Australia, its member associations, the PGA of Australia and the WPGA Tour of Australasia remains a key focus of the national strategy released for golf in Australia in late 2021. The Golf Victoria board was an active contributor to the formulation of the strategy for golf in Australia for the period 2022 – 2025 which adopts a broader remit in relation to the promotion of golf as is indicated by the Purpose, Philosophy and Positioning statements.

1. SUMMARY OF MATERIAL ACCOUNTING POLICIES

This note provides a list of all material accounting policies adopted in the preparation of these financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated. The financial statements are for Golf Victoria Limited (the "Company").

(a) Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board and the Corporations Act 2001. Golf Victoria Limited is a not-for-profit entity for the purpose of preparing financial statements.

(i) Compliance with Australian Accounting Standards - Simplified Disclosure Requirements

The financial statements of the Company comply with Australian Accounting Standards - Simplified Disclosures as issued by the Australian Accounting Standards Board (AASB).

(ii) Historical cost convention

The financial statements have been prepared on a historical cost basis, unless otherwise stated.

(iii) Comparatives

The financial statements have been prepared on a historical cost basis, unless otherwise stated.

(iv) New and amended standards adopted by the Company

The Company has applied the following standards and amendments for the first time in their annual reporting period commencing 1 July 2023:

- AASB 17 Insurance Contracts
- AASB 2023-2 Amendments to Australian Accounting Standards - Definition of Accounting Estimates
International Tax Reform - Pillar Two Model Rules [AASB 112]
- AASB 2021-5 Amendments to Australian Accounting Standards - Deferred Tax related to Assets and Liabilities arising from a Single Transaction [AASB 112]
- AASB 2021-2 Amendments to Australian Accounting Standards - Disclosure of Accounting Policies
Definition of Accounting Estimates [AASB 7, ASB 101, AASB 108, AASB 134 & AASB Practice Statement 2]

The amendments listed above did not have any impact on the amounts recognised in prior periods and are not expected to significantly affect the current or future periods.

(b) Foreign currency translation

Items included in the financial statements are measured using the currency of the primary economic environment in which the entity operates ('the functional currency').

(c) Revenue recognition

Revenue is recognised at the fair value of consideration received or receivable. Amounts disclosed as revenue are net of taxes paid. Revenue is recognised for the major business activities using the methods outlined below:

(i) Government grants

Where Government grants are received with specific performance obligations attached to the grant that stipulate the manner in which the grant is to be acquitted, the entity recognises revenue when (or as) the entity satisfies a performance obligation by transferring a promised good or service to the Government and/or third-party beneficiaries.

The grant is recognised in the statement of financial position as a liability until the conditions attached to the grant are met. Non-Government grants are recognised as revenue when (or as) the entity satisfies a performance obligation by transferring a promised good or service to the third-party beneficiaries.

(ii) Affiliation and member fees

Affiliation and member fees are recognised as revenue as performance obligations are met and the service is rendered to members throughout the year.

(iii) Interest income

Interest income is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

(iv) Other income

Other income is recognised in the period in which it is received.

(d) Income tax

Golf Victoria Limited is exempt from income tax under section 50-45 of the Income Tax Assessment Act 1997. Golf Victoria Limited assesses and determines its exemption on an annual basis in accordance with relevant legislation.

(e) Impairment of non-financial assets

Assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

The recoverable amount is based on an asset's fair value less costs to sell. Where the future economic benefits of an asset are not primarily dependent on the asset's ability to generate net cash inflows, fair value is determined as the current replacement cost of the asset.

For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets previously impaired are reviewed for possible reversal of the impairment at the end of each reporting period.

(f) Cash and cash equivalents

For the purpose of presentation in the statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(g) Trade receivable

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business. They are generally due for settlement within 30 days and are therefore all classified as current. Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Company holds the trade receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method.

The Company applies the AASB 9 Financial Instruments simplified approach to measuring expected credit losses which uses a lifetime expected loss allowance for all trade receivables and contract assets.

(h) Contract assets

A contract asset is the right to receive consideration in exchange for services rendered to the customer. Contract assets are recognised to the extent that services have been rendered but not yet invoiced and at an amount that reflects the consideration to which the Company expects to be entitled in exchange for the services rendered. Contract assets are subject to impairment assessment.

(i) Term deposits

At initial recognition, the Company measures a term deposit at its fair value. Subsequently, term deposits are measured at amortised cost using the effective interest method. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss and

presented in other gains/(losses). Impairment losses are presented as separate line item in the statement of profit or loss and other comprehensive income.

(j) Property, plant and equipment

Property, plant and equipment is stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to profit or loss during the reporting year in which they are incurred.

Depreciation is calculated using the straight-line and reducing balance method to allocate the cost or revalued amounts of the assets, net of their residual values, over their estimated useful lives, as follows:

Buildings	30 years
Property Plant and Equipment	3-10 years
Furniture, fixture and fittings	3-10 years
Vehicles	5 years

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (note 1(e)).

Gains and losses on disposals are determined by comparing proceeds with carrying amount.

These are included in profit or loss. When revalued assets are sold, it is Company policy to transfer any amounts included in other reserves in respect of those assets to retained earnings.

(k) Trade and other payables

These amounts represent liabilities for goods and services provided to the Company prior to the end of financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months from the reporting date.

They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

Where trade payables are settled via electronic cash transfer, they are derecognised when the Company has no ability to withdraw, stop or cancel the payment, has lost the practical ability to access the cash as a result of the electronic payment instruction and the risk of a settlement not occurring is insignificant.

(l) Contract liabilities

A contract liability is the obligation to transfer goods or services to a customer for which the Company has received consideration (or an amount of consideration is due) from the customer. If a customer pays consideration before the Company transfers goods or services to the customer, a contract liability is recognised when the payment is made or the payment is due (whichever is earlier). Contract liabilities are recognised as revenue when the Company performs under the contract.

(m) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the taxation authority. In this case it is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the taxation authority is included with other receivables or payables in the Statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the taxation authority, are presented as operating cash flows.

2. CRITICAL ESTIMATES AND JUDGEMENTS

The preparation of financial statements requires the use of accounting estimates which, by definition, will seldom equal the actual results. Management also needs to exercise judgement in applying the Company's accounting policies.

(a) Significant estimates and judgements

Estimates and judgements are continually evaluated. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.

The company has revised its estimate of the useful life of the Australian Golf Centre building from 40 years to 30 years. The change in estimate has been applied from 1 July 2023. It has also updated its policy to depreciate this asset using the straight-line method.

(b) Critical accounting estimates and assumptions

The preparation of financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Company's accounting policies.

Determining the recoverable amount of the asset the Company holds in relation to the Australian Golf Centre (within property, plant, and equipment) requires estimation.

The asset is not currently generating net cash inflows for Golf Victoria, but it continues to make a strong contribution to the game of golf in Australia through its use by Golf Australia and the PGA of Australia. As such, assessing whether the asset is impaired involved estimating its current replacement cost, which is based on the cost to a market participant to acquire or construct a substitute asset of comparable utility, adjusted for obsolescence. The asset's replacement cost is estimated to be higher than its carrying value at 30 June 2024.

There are no other areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the financial statements.

Australian golf centre project

During the period, the sub-lease between Bayside Council, Sandringham Golf Links Management Pty Ltd (SGLM) and Golf Victoria Limited continued under which nominal rent is paid by Golf Victoria Limited for use of the Australian Golf Centre facilities. There are separate licences to occupy these facilities conferred on Golf Australia Limited (GA) and the Professional Golfers Association of Australia (PGA) by Golf Victoria Limited, together with the sub-sub-lease between Golf Victoria Limited and SGLM for SGLM's use of the cafe in the facilities. Operating expenses referable to these leases and licences and the running of these facilities are paid by GA, the PGA and SGLM for Golf Victoria Limited's benefit. During the period, **\$288,155 (2023: \$257,871)** was brought to account in accordance with AASB 1058 Income of Not-for-Profit Entities as contributions revenue in respect of this.

GA, the PGA and SGLM have also collectively contributed **\$86,568 (2023: \$75,000)** for a building fund recognised as deferred revenue at reporting date. These funds will be recognised as revenue as Golf Victoria Limited satisfies its sub-lease obligations for repairs and maintenance.

Grant revenue

Australian golf centre project

Following the 2014 state government election commitment to provide \$15.3M to fund the construction of a National Home of Golf facility, Golf Victoria Limited, GA, SGLM and the PGA of Australia developed a joint project proposal to develop the Sandringham Golf Course as the Australian Golf Centre.

During the financial year ended 30 June 2023, the final balance of \$44,853 of the project funds was recognised as grant revenue as Golf Victoria Limited satisfied its obligations under the grant agreement, being the construction of the asset.

Victorian programs

Victorian programs grants revenue of \$nil (2023: \$90,000) is the state government grants received for the Together More Active, Future Healthy and Freestyle Golf Programs. An equal amount was paid to GA for its operational management of the program under the Australian Golf State Services agreement and reported as grant expense. Further details of the Australian Golf State Services agreement are set out in note 16.

15. BELOW-MARKET VALUE LEASES

The Company has various leases in respect of the Australian Golf Centre, one as sublessee and the others as lessor. It has a lease agreement with Sandringham Golf Links Management Pty Ltd (as sublessee) for the right to use the land on which the Australian Golf Centre resides at the Sandringham Golf Links site in Cheltenham, Victoria and it has license agreements (as lessor) with Golf Australia Limited, SGLM and the PGA of Australia for the right to use the Australian Golf Centre.

15. BELOW-MARKET VALUE LEASES (CONTINUED)

Both the contracts contain pricing terms which are substantially below market value. The fee payable to Sandringham Golf Links Management Pty Ltd is \$1 per sqm (plus GST) per annum and the fee receivable from Golf Australia Limited is \$1 (plus GST) per annum. The original term under the contracts is 5-years from 19 May 2020 with an option for future extension up to a further five terms each comprising 5-years subject to agreement with the parties.

Golf Victoria Limited elected to measure the right-of-use of asset in relation to the land it leases from Sandringham Golf Links Management Pty Ltd at cost on initial recognition rather than at fair value. The value of the right-of-use asset measured at cost is not material.

Victorian Golf Foundation: Golf Victoria Limited together with the former Womens Golf Victoria resolved in 1986 to establish the Victorian Golf Foundation to aid in the development of golf in Victoria. The assets of the Foundation are held by the Victorian Golf Foundation Pty Ltd as the custodian for the trustees of the Victorian Golf Foundation.

Golf Australia Limited: In late September 2018, Golf Victoria Limited entered into an agreement (the "Australian Golf State Service Agreements") with Golf Australia Limited pursuant to which the parties agreed that Golf Australia Limited will provide particular services, as specified in the Australian Golf State Services Agreements, for the benefit of Golf Victoria Limited and the members which Golf Victoria Limited had previously provided directly to its members.
