SUBJECT: Reminder of required Golf Australia CONNECT Use Agreement for Organisations signing

You are receiving this communication as you were registered as a club/venue administrator that required updates on the GOLF Link / Golf Australia CONNECT transition project. This information is specific to club and venue administrators.

Golf Australia CONNECT use agreement for Organisations – May 30 signing deadline

In March this year, the Golf Australia CONNECT Use Agreement for Organisations was circulated to club and venue administrators, including explanatory notes regarding the changes to the initial version sent in October, 2024.

The purpose of this communication is to remind all club and venue administrators of the deadline for signing the document digitally by **Friday, May 30, 2025**.

- Club physical address
- Organisation type (Incorporated Association, or Other).
- If you currently engage any GA-Licensed Software Provider/s (including MiClub Golf, MiClub OneGolf, Golf Magic, SimpleGolf, GolfBox, Golf Genius).
- Primary and Secondary Contacts – Your club officials who are authorised to sign this agreement and activate your Golf Australia CONNECT account with the following details: Name, Email Address, Position, Phone Number.
