Golf Australia CONNECT Use Agreement for Organisations – Execution of Agreement

In October of 2024, Golf Australia circulated a new "Golf Australia CONNECT Use Agreement for Organisations" intending to supersede the GOLF Link service agreement between clubs and Golf Australia.

Following consultation and feedback from club and venue administrators, as well as from Member States and Golf Management Australia, there have been some amendments made to the agreement. Those changes are detailed below under explanatory notes. The agreement has now been finalised and is presented to clubs and venues for digital signing. Golf Australia requests that clubs sign the document digitally by **Friday**, **May 30**, **2025**.

VIEW EXPLANATORY NOTES

The signing process will take place in two parts. Part one is the completion of the onboarding form, part two is the

signing of the digital document by your organisation's representatives.

The onboarding form will collect information from your organisation to enable us to tailor the onboarding process to suit your requirements. You will need to gather the following information before completing the onboarding form.

- Organisation legal entity name.
- · Organisation physical address.
- Organisation type (Incorporated Association, or Other).
- If you currently engage any GA-Licensed Software Provider/s (including MiClub Golf, MiClub OneGolf, Golf Magic, SimpleGolf, GolfBox, Golf Genius).
- Primary and Secondary Contacts Your club officials who are authorised to sign this agreement and
 activate your Golf Australia CONNECT account with the following details: Name, Email Address, Position,
 Phone Number.

Once you have completed the onboarding form, the Golf Australia CONNECT use agreement for organisations will be automatically emailed to your organisation's representatives for digital signing.

The email will be sent from 'Golf Australia via Jotform Sign <noreply@jotformsign.com>'. The body of the email will contain the phrase 'Matt Chesterman (matt.chesterman@golf.org.au) has invited you to sign Golf Australia CONNECT Use Agreement Organisations 2025 Final'.
