State/Territory Guidelines

Please note all below information is relevant as of 23/06/2020. Fees and processes may change so please check state/territory websites for most up to date information.

Employee or Volunteer Working with Children Clearance	<ul style="list-style-type: none">○ If you intend to only deliver Golf Australia's participation programs through voluntary means at your local golf club and receive no payment, a volunteer Working with Children Check is satisfactory.○ If you intend to deliver Golf Australia's participation programs at your local golf club or through Sporting Schools where you will receive payment, you will need to ensure you have an employee Working with Children Check. The links below for each state provide information on how to apply, renew or transfer your WWCC from volunteer to employee.
<u>ACT</u>	<ul style="list-style-type: none">○ Type of Check: Working with Vulnerable People (WWVP)○ Age requirement: 16 years and over are required to obtain a WWVP check○ Fees:<ul style="list-style-type: none">- Employee = \$135- Volunteer = Free○ Format: WWVP card, then renewal receipt that will be evidence of check○ Valid: 5 years
<u>NSW</u>	<ul style="list-style-type: none">○ Type of check: Working with Children Check (WWCC)○ Age requirement: 18 years and over are required to obtain a WWCC○ Fees:<ul style="list-style-type: none">- Employee = \$80- Volunteer = no fee○ Format: certified through email notification○ Valid: 5 years
<u>NT</u>	<ul style="list-style-type: none">○ Type of check: Ochre Card○ Age requirement: 15 years and over required to obtain Ochre card○ Fees:<ul style="list-style-type: none">- Employed = \$72- Volunteer = \$7○ Format: Ochre card○ Valid: 2 years
<u>QLD</u>	<ul style="list-style-type: none">○ Type of check: Blue Card○ Age requirement: 18 years and over, (if under 18 and undertaking paid work, must also obtain Blue Card)○ Application process: must get golf club/school at which you plan to deliver to fill in application form○ Fees:<ul style="list-style-type: none">- Employed = \$92- Volunteer = no fee○ Format: Blue card or Exemption Card (registered teacher)○ Valid: 3 years
<u>SA</u>	<ul style="list-style-type: none">○ Type of check: DHS Screening Unit – 'cleared'○ Age requirement: 14 years and over required to obtain clearance○ Fees:

	<ul style="list-style-type: none"> - Employee= \$113.30 (general), \$62.15 (students) - Volunteer = no fee o Format: Clearance letter through email notification o Valid: 5 years
TAS	<ul style="list-style-type: none"> o Type of check: Working with Vulnerable People (WWVP) o Age requirement: 16 years and over required to obtain WWVP clearance o Fees: <ul style="list-style-type: none"> - Employee= \$113.40 - Volunteer = \$19.40 o Format: WWVP card o Valid: 3 years
VIC	<ul style="list-style-type: none"> o Type of check: Working with Children Clearance (WWCC) o Age requirement: 18 years and over required to obtain WWCC o Fees: <ul style="list-style-type: none"> - Employee (new check) = \$126.50 - Volunteer = no fee - Renewal fee = \$93.60 o Teachers: exempt from WWCC, but must notify WWCC Victoria if doing child-related work outside of school/childcare setting o Format: WWCC Card o Valid: 5 years
WA	<ul style="list-style-type: none"> o Type of check: Working with Children Clearance (WWCC) o Age requirement: 18 years and over required to obtain WWCC, (if under 18 and undertaking paid work, must also obtain WWCC) o Fees: <ul style="list-style-type: none"> - Employee= \$87 excl. GST - Volunteer = \$11 excl. GST o Application process: must get golf club/school at which you plan to deliver to fill in application form o Format: WWCC card o Valid: 3 years
