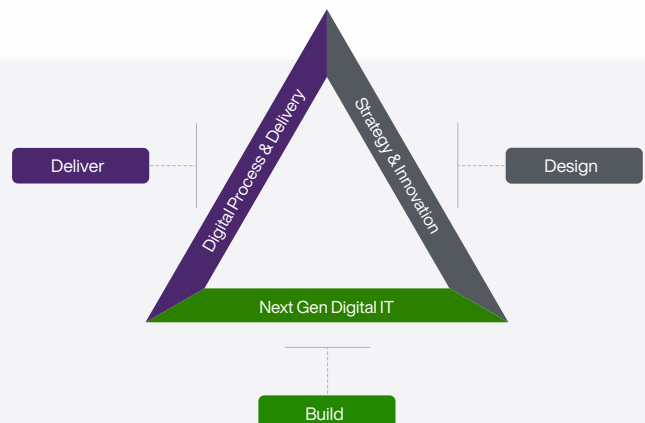

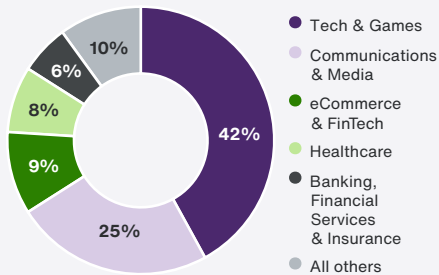

## Revenue diversification

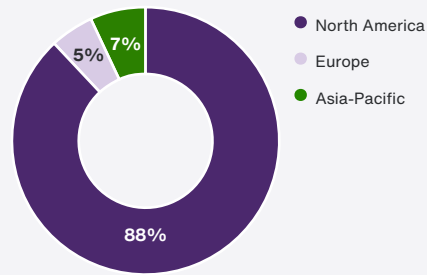
### By Vertical (Q3'24)

As of September 30, 2024



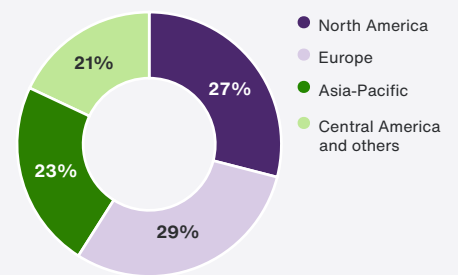
### By Client Location (Q3'24)
