

Terms & conditions

Up to £100 of GoCardless transaction fees reimbursed when you create a GoCardless account and activate it on the FreeAgent platform.

Details of the offer-

Promotion:

Up to £100 of GoCardless transaction fees reimbursed when you create a new GoCardless account and connect it to the FreeAgent platform to process payments. Existing customers are eligible if no payments have been processed prior to the promotion start date.

How to Qualify:

To enter the Promotion, Eligible Participants must: i) create a GoCardless account between 1st December 2020 - 29th January 2021 OR hold an inactive GoCardless account which has not processed any payment prior to 1st December 2020 ii) Connect the GoCardless account to FreeAgent, iii) Complete GoCardless account verification according to the terms of the GoCardless merchant agreement iv) Create and receive payments via the GoCardless for FreeAgent by 31st January 2021

Eligible Participant

New FreeAgent customers or existing FreeAgent customers who are new to GoCardless (meaning that they have signed up for GoCardless through FreeAgent or connected an existing, inactive GoCardless account to FreeAgent) and who process pay enabled invoices via GoCardless on the FreeAgent platform on or before the expiry of the Fee Waiver Promotion Period and are based in the United Kingdom.

Eligible Transaction(s)

Invoice settlement payments made by GoCardless [Direct Debit] against invoices issued via FreeAgent by the Eligible Participant, and settled via FreeAgent, during the Fee Waiver Promotion Period which incurs GoCardless Transaction fees. The invoice payee must be based in the United Kingdom. Only transaction fees are included within the promotion.

Promotion period

Sign up period

To be eligible participants must activate a GoCardless account on the FreeAgent platform within the following start/end dates:

Starts at 12:01:00 a.m. Greenwich Mean Time ("GMT") on 1st December 2020 and ends at 11:59:00p.m. GMT on 29th January 2021.

Fee Waiver Promotion Period

Fees paid on transactions initiated in the Fee Waiver Period will be reimbursed. This period starts at 12:01:00 a.m. Greenwich Mean Time GMT on 1st December 2020 and ends at 11:59:00p.m. Greenwich Mean Time GMT on 31st March 2021.

Cap

Each Eligible Participant shall be entitled to a maximum fee reimbursement total of GBP£100.

Fees Reimbursement

GoCardless shall reimburse the Eligible Participant for GoCardless Transaction fees applied on Eligible Transactions up to the Cap. Only Transaction fees incurred up to the Cap shall be eligible for reimbursement upon expiry of the Fee Waiver Promotion Period. For the avoidance of doubt, only transaction fees are included in the promotion. Any Monthly Fees or Contractual Commitments are not included in the Promotion.

Reimbursements will not be awarded on invoices issued and/or settled after i) the Eligible Participant reaches the Cap; ii) the Fees Waiver Period expires or iii) which are processed outside of the FreeAgent platform.

Reimbursement is a one-time payment made directly into the Eligible Participant's GoCardless nominated bank account after the promotion period. The Reimbursement will be credited to the Eligible Participant account within 21 days from the end of the Fee Waiver Promotion Period.
