Promotion

Complete six (6) Eligible Payment Actions (see below) using your GoCardless account before the end of the Promotion Period and get either £300 in Kelme UK gift cards for a new football kit for your football team or a £150 SportsNetWorld voucher towards training equipment (the “**Prize**”).

How to Qualify

To enter the Promotion, Eligible Merchants must complete the Eligible Payment Actions (to become an “**Active Eligible Merchant**”) before the end of the Promotion Period, subject to the terms and conditions below.

Eligible Merchants

Eligible Merchants are entities registered in the United Kingdom and football clubs located in the United Kingdom, that created a self-serve GoCardless account during the Promotion Period via a unique referral link and have not, by the start date of the Promotion Period, activated their GoCardless account by processing a payment via GoCardless.

Eligible Payment Actions

There are two actions that count as an Eligible Payment Action: (i) the Eligible Merchant creating a direct debit and/or instant bank pay (“IBP”) mandate, or (ii) the Eligible Merchant collecting a direct debit and/or IBP transaction using their GoCardless Account, subject to the terms and conditions below, during the Promotion Period.

Promotion Period

Starts at 00:00 GMT on 29 November 2025 and ends at 11:59 GMT on 30 November 2026 at 23:59 GMT.

Prize

Eligible Merchants who meet the criteria outlined in these terms and conditions will be eligible to choose between either £300 in Kelme UK gift cards or a £150 SportsNetWorld voucher towards training equipment



TERMS AND CONDITIONS

Please read the following terms and conditions before you participate in the GoCardless Football Club Activation Program (“the **Promotion**”). The following Terms and Conditions will apply. If you do not agree with these Terms and Conditions you must not participate in the Promotion.

1. PROMOTER

1.1. The Promoter of the Promotion is GoCardless Limited registered in England and Wales under company number 07495895 and whose registered office address is Sutton Yard, 65 Goswell Road, London, EC1V 7EN, United Kingdom (referred to as “GoCardless”, “we”, “us”, “our”).

2. THE PROMOTION; ENTRY REQUIREMENTS

2.1. Participation in the Promotion is limited to Eligible Merchants. An Eligible Merchant is a GoCardless customer that:

- a. Is a United Kingdom registered entity;
- b. Is a football club located in the United Kingdom;
- c. Created a self-serve GoCardless account during the Promotion Period via a unique referral link;
- d. Has not, by the start date of the Promotion Period, activated their GoCardless account by processing a payment via GoCardless; and
- e. Has received an email to be a part of this GoCardless Promotion.

(“**Eligible Merchants**”)

2.2. To enter the Promotion, Eligible Merchants must successfully complete six (6) payment actions through their GoCardless Account (to become an “**Active Eligible Merchant**”) before the end of the Promotion Period.

2.3. There are two (2) payment actions that count as an Eligible Payment Action - (i) creating a direct debit and/or IBP mandate, or (ii) collecting a direct debit and/or IBP transaction. In the context of (ii) if the transaction is *created* by an Eligible Merchant during the Promotion Period, but not *collected* by GoCardless until after the Promotion Period, this will not be classified as an Eligible Payment Action, and the Eligible Merchant will therefore not be deemed an Active Eligible Merchant (“**Eligible Payment Actions**”).

2.3. The Promoter accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason.

3. START AND END DATES

3.1. The promotion period commences at 00:00 GMT on 28 November 2024 and ends at 23:59 GMT on 28 November 2025 (“**Promotion Period**”).

3.2. Entries received before or after the Promotion Period will not be accepted and will be invalid unless otherwise decided by GoCardless acting in its sole discretion.

4. THE PRIZE

4.1. Eligible Merchants that meet the criteria set out in these terms and conditions will be given the choice to choose between either £300 in Kelme UK gift cards or a £150 SportsNetWorld voucher (“**Prize**”). Eligible Merchants will be contacted by email on or around 30 days after the Promotion Period ends to choose their gift card. The Prize will then be sent to the email address that is recorded on the winner’s GoCardless account.

4.2. Eligible Merchants are liable for any tax consequences of the receipt of the Prize, and GoCardless accepts no liability to Eligible Merchants or Eligible Merchants in relation thereto.

5. RESTRICTIONS AND REQUIREMENTS

5.1. Access to the Internet is required in order to participate in this Promotion.

5.2. The Promoter reserves the right to withdraw or restrict the Promotion and these Terms and Conditions at any time without notice.

6. FAIR USE

6.1. If the Promoter has reasonable grounds to believe that an Eligible Merchant has engaged in any fraud or abuse of this Promotion, we may at our sole discretion take any actions we see fit in such circumstances, including but not limited to cancelling, terminating, withdrawing, modifying, restricting or suspending the Promotion or these Terms and Conditions.

6.2. If any Eligible Merchant attempts to circumvent the terms of this Promotion, including by creating multiple GoCardless accounts, such Eligible Merchant’s participation in the Promotion will be suspended and their GoCardless account may be suspended or closed.

7. LIMITATION OF LIABILITY

7.1. The Promoter shall not be liable to any Eligible Merchant if they suffer any loss or damage from the Promotion (including without limitation any loss of profits, loss of revenue, loss of goodwill that arises out of or in connection with the Promotion) or from the Promoter’s refusal to allow an Eligible Merchant to take part in the Promotion or our withdrawal of the Promotion or any other failure or inability by an Eligible Merchant to participate in or benefit from the Promotion for any reason. Nothing in these Terms and Conditions excludes or limits the Promoter’s liability in respect of personal injury or death caused by our negligence, or for fraud.

7.2. Nothing in these terms and conditions excludes or limits The Promoter’s liability in respect of: (i) death or

personal injury caused by our own negligence; (ii) fraud or fraudulent misrepresentation by us or our employees; or (iii) any other liability which may not be limited or excluded under applicable law.

7.3. The Promoter shall not be liable for: (i) any failure to comply with these terms and conditions as a consequence of events beyond its reasonable control including without limitation, any failure of communication networks as a consequence of any circumstances beyond the reasonable control of The Promoter; and/or (ii) any loss of profits, loss of revenue or other economic loss or any indirect or consequential loss.

7.4. The Promoter does not recommend or guarantee the performance of any contractual or other obligations of any third parties mentioned in these Terms and Conditions. Nothing in these Terms and Conditions will limit the Promoter's liability for death or personal injury caused by its negligence or for fraud.

7.5. To the extent permitted by applicable law, the Promoter's liability under or in connection with the Promotion or these Terms and Conditions shall be limited to the retail price of the Prize in question.

8. GENERAL

8.1. In the event of unforeseen circumstances beyond the Promoter's reasonable control, the Promoter reserves the

right to cancel, terminate, withdraw, modify, restrict or suspend the Promotion or these Terms and Conditions, either in whole or in part, with or without notice.

8.2. Eligible Merchants in the Promotion are deemed to have read and accepted these Terms and Conditions.

8.3. By entering the Promotion each participant gives The Promoter permission to publish their company name and county of residence unless the participant notifies The Promoter that they do not wish us to make these details available. Please note that The Promoter will nonetheless be required to provide the names of all gift card winners to the Advertising Standard Authority if requested to do so.

8.4. These Terms and Conditions (and any contractual or non-contractual disputes arising out of or in connection with them) shall be governed by and construed in accordance with the laws of England and Wales and any disputes relating or connected to these terms and conditions shall be subject to the exclusive jurisdiction of the English Courts.
