Merchants must pay: (a) Transaction Fees, which apply to all relevant features in the Product Bundle; (b) Ancillary Fees, which are additional to Transaction Fees charged; and (c) Add-On Features, which are additional to Transaction Fees and Ancillary Fees, and depend on whether (i) such Add-On Features being available in the chosen Product Bundle, and whether (ii) such Add-On Features have been activated.

Transaction Fees

The below table sets out the fee per Transaction, (the "Transaction Fee") for each Product Bundle, for payments processed by GoCardless under the GoCardless Payments Service as part of your Product Bundle. Transactions which exceed the High Value Transaction Threshold as set out in the table below, shall be charged a High Value Transaction Fee (as set out in the table below) in addition to the Domestic Transaction Fee, for the value of the Transaction that is in excess of the High Value Transaction Fee Threshold. International Transactions will not be subject to the High Value Transaction Fee. For example, for a UK based Merchant, for a Transaction of £3,000 GBP, £1,000 will be subject to the 0.3% High Value Transaction Fee as it exceeds the £2,000 High Value Transaction Threshold.

Ancillary Fees

Except for the use of the ACH Payment Scheme and the SEPA Payment scheme for Merchants based in Germany and Austria, Merchants with less than 100 Transactions per month won't be charged Chargeback Fees.
