Reliable, predictable access to power is critical to operating your business. With PGE's Dispatchable Standby Generation (DSG) onsite generation or battery storage solutions, you'll have the peace of mind that comes with a backup resource.

Participating in PGE's Dispatchable Standby Generation program makes a big impact. Not only do you get paid when you enroll, but you'll help keep the lights on in times of need. You'll even receive post-event notifications to let you know how your participation in the program helps provide reliable power to our community.

### When you partner with PGE:

- Your backup generation will be there for you during any outage. PGE only uses the generator when you have full power.
- Our DSG program provides an upfront allowance of \$94.80 per kW for each year of the contract. The first dollars are used to sync the generator with the grid. Anything leftover is paid directly to the customer once the generator is active in the program.
- PGE will pay for and perform routine maintenance, monitor health and performance of the system, and keep your generator fueled, even during an outage when you enroll.
- PGE contributes to any necessary repairs on the generator, up to \$30,000 per occurrence.
- Our team can help you navigate regulations and requirements with the Oregon Department of Environmental Quality, plus be there to help answer any questions you have.

Whether you enroll with a diesel or natural gas generator, or a battery, we'll pay you for the shared access to your system.

- For generators, we pay **\$94.80 per kW**.
- For batteries, that goes up to **\$137.40 per kW**.

### Generator example

A manufacturing company who enrolls a **1 MW generator** in Dispatchable Standby Generation with a 10-year term.

$$\begin{array}{r} \$94.80 \text{ per kW} \\ \times \quad 1,000 \text{ kW} \\ \times \quad 10 \text{ year term} \\ \hline = \quad \mathbf{\$948,000 \text{ upfront incentives}} \\ - \quad \$200,000 \text{ estimated PGE} \\ \quad \quad \text{construction costs} \\ \hline \mathbf{\$748,000 \text{ estimated net pay out}} \end{array}$$

### Battery example

A manufacturing company who enrolls a **1 MW battery** in Dispatchable Standby Generation with a 10-year term.

$$\begin{array}{r} \$137.40 \text{ per kW} \\ \times \quad 1,000 \text{ kW} \\ \times \quad 10 \text{ year term} \\ \hline = \quad \mathbf{\$1,374,000 \text{ upfront incentives}} \\ - \quad \$70,000 \text{ estimated PGE} \\ \quad \quad \text{construction costs} \\ \hline \mathbf{\$1,304,000 \text{ estimated net pay out}} \end{array}$$
