These estimated rates include the PPC (Public Purpose Charge) and the LIA (Low Income Assistance) adjustments. The PPC and LIA adjustments are mandated by Oregon Law to be collected by PGE. In addition, these funds are directed for the benefit of the public and are disbursed by public agencies. Actual LIA billing amounts will vary depending on the total number of kilowatt hours used for the lights that are billed. In addition to PPC and LIA, other jurisdictional taxes or fees may apply.
