REQUEST FOR PROPOSAL ("RFP")

Environmental Permits and Land Use Authorizations for the Warm Springs Power Pathway Project

THIS RFP AMENDMENT #5 IS RAISED TO:

1. Respond to supplier questions;
2. Amend the "Intent to Award" definition in Section 1: General Information of the RFP;
3. Amend the "Protest of Intent to Award" in Section 2: Offeror Instructions of the RFP;
4. Amend the "Activity" in the RFP and Contract Award Timeline in Section 3: Proposal Preparation Instructions of the RFP; and
5. Amend the Master Purchase Agreement Template in Annex H.

THIS RFP AMENDMENT #5 IS HEREBY AMENDED AS FOLLOWS:

1. **DELETE** the below paragraph from Section 9 in *Section 1: General Information* on page 9 of the RFP:

c. "Intent to Award" is a written notice, advertising to whom the contract award will be awarded to. This notice will be published on the PGE website for a minimum of seven (7) calendar days prior to awarding the contract to the highest-scored Offeror.

and **REPLACE** it with:

c. "Intent to Award" is a written notice, advertising to whom the contract award will be awarded. This notice will be sent to all Offerors by email when a selection is made in relation to this RFP.
2. **DELETE** the below paragraph from Section 24 in *Section 2: Offeror Instructions* on page 13 of the RFP:



- All protests must be electronically received no later than 4:00 P.M. PDT on the seventh calendar day after the notice of intent to award or disqualification has been posted on the PGE website.

and **REPLACE** it with:

- All protests must be electronically received no later than 4:00 P.M. PDT on the seventh calendar day after the notice of intent to award or disqualification has been sent to the Offerors by email.

3. **DELETE** "Notice of Intent to Award published on PGE website" from Section 5 on page 15 of the RFP, and **REPLACE** it with:

4. **ADD** an asterisk right after "time spent traveling" and right after "travel to/from home/hotel to assigned work location" on page 23 in the Master Purchase Agreement Template in Annex H. Also **ADD** the below paragraph right after the list of bullet points within the section titled Unauthorized Charges:

* PGE will compensate the Contractor for travel time while working along the alignment, which will be between the Bethel substation near Salem, Oregon, and the new switchyard near the Round Butte substation in Madras, Oregon. However, PGE won't pay for any surveyor's travel time between Portland, OR and the alignment location. Moreover, PGE will compensate the Contractor for time spent traveling for mandatory in-person meetings directly between Portland, OR and the meeting location, but will not pay the Contractor for time spent traveling to Portland from their place of origin.

ALL OTHER INFORMATION IN THIS RFP REMAINS THE SAME.
