RATE SHEET FOR MACRO SITES

Rate Schedule for Macro Sites on PGE Facilities

Below are the rental rates PGE will charge for antennas and other equipment associated with Macro Sites on PGE facilities, which include wood utility poles, steel poles and steel transmission towers. PGE will increase rates by 50% for each additional user of any shared antennas and/or equipment.

The monthly rates for antennas associated with Macro Sites:*

For each of the first three antennas: \$200 per antenna

\$100 Additional for Rad Center above 90'AGL (Not per antenna)

For each of the next three antennas: \$140 (Assumes same Lessee's antennas)

\$70 Additional for Rad Center above 90'AGL (Not per antenna)

For each of the next three antennas: \$100 (Assumes same Lessee's antennas)

\$50 Additional for Rad Center above 90'AGL (Not per antenna)

There is a \$50 charge for GPS and E911 antennas with effective wind areas not to exceed 0.25 square feet mounted to PGE's structure.

***These rates apply only to antennas with an effective wind area of six (6) square feet or less and up to a maximum of nine (9) antennas. Rates for antennas that exceed an effective wind area of six (6) square feet, or for Macro Sites that include more than nine (9) antennas, are negotiable and are not subject to this Rate Schedule.**

The monthly rate for equipment cabinets mounted on poles and towers for Macro Sites:**

For each cabinet weighing between 75 and 399 pounds or having a volume between one and 9.9 cubic feet: \$200.

For equipment weighing less than 75 pounds and having a volume less than one cubic foot: \$100.

Remote Radio Units are calculated at \$ 100 per unit with a negotiable discount for multiple units.

****These rates apply *only* to equipment cabinets that weigh less than 400 pounds or have a volume of less than 10 cubic feet. Rates for equipment cabinets that weigh 400 pounds or greater, or have a volume of 10 cubic feet or greater, are negotiable and are not subject to this Rate Schedule.**

Reduction of rates and minimum rates for Macro Sites:

These rates described herein are subject to reduction at PGE's sole discretion, but in no event shall the rates for antenna and equipment be less than \$600 per site, \$450 for antennas only, \$200 or \$100 for equipment only, calculated by weight and size as defined above.

Definitions:

The term "antenna" means an apparatus designed for the purpose of emitting radio-frequency (RF) radiation, to be operated or operating from a fixed location pursuant to FCC authorization, for the provision of personal wireless service and any commingled information services.

The term "mounting height" means the antenna centerline height ("Rad Center") above ground level.
