PGE's Energy Burden Assessment Findings



- PGE agreed to complete this assessment and file it with the Oregon Public Utility Commission (OPUC) by June 30, 2024
- PGE contracted a third-party vendor to complete this work
- The following information is the analysis and recommendations of Hassan Shaban of Empower Dataworks provided to PGE



PGE Energy Burden Assessment Next Steps

- Report, Findings and Recommendations to be filed June 28, 2024
- PGE to file a "new discount program" by September 27, 2024
- Continue sharing of learnings and feedback internally
- PGE to provide updates on this work to maintain feedback loop
