

Official Rules

PGE Spectrum Sweepstakes (the “Sweepstakes”)

Sweepstakes Description / How to Enter: NO PURCHASE OR PARTICIPATION IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. PARTICIPATION CONSTITUTES PARTICIPANT'S FULL AND UNCONDITIONAL AGREEMENT TO AND ACCEPTANCE OF THESE OFFICIAL RULES. The Sweepstakes is sponsored by Portland General Electric Company, 121 SW Salmon, 1WTC0403, Portland, OR 97204 (“Sponsor”).

ELIGIBILITY: PGE’s Sweepstakes (the “Sweepstakes”) is open to anyone who stops by the PGE booth at the 2020 virtual Spectrum tradeshow, who are the legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of PGE and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations.

How to Enter: The Sweepstakes begins on Monday, September 14, 2020 at 8 a.m. PT and ends on Friday, September 18, 2020 at 5 p.m. PT (“Entry Period”). During the Entry Period, there is one way to enter. You must stop at the virtual booth and use the inquiry form in the Contact Us section of our profile. No other method of entry will be accepted. Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void.

All online entries must include a valid e-mail address for the entrant. In case of multiple entries received from any person or e-mail address or household, only the first entry received from such person, e-mail address or household will be considered. In the event of a dispute as to the identity or eligibility of a Winner based on an e-mail address, the winning entry will be declared made by the “Authorized Account Holder” of the e-mail address submitted at the time of entry provided he/she is eligible according to these Official Rules. The “Authorized Account Holder” is defined as the natural person to whom the applicable Internet service provider or other organization (such as a business or educational institution) has assigned the e-mail address for the domain associated with the submitted e-mail address. PGE reserves the right to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.

Prize Pickup: Winner is responsible for picking up the Prize at 121 SW Salmon, Portland, OR 97204 (including all transportation costs associated therewith). PGE and Winner will coordinate on the timing of the pick-up. PGE is unable to mail, ship or otherwise deliver the Prize.

Random Drawing: The potential winner of the Sweepstakes ("Winner" will be selected by random drawing on or about September 25, 2020 from among all eligible entries received by PGE. The decisions of PGE are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period. Limit one (1) prize per person, family and per household.

Prizes: One (1) Prize is available to be awarded ("Prize"). The Winner will receive an inflatable kayak for two, including pump, paddles, and two adult life vests plus a gift certificate for two nights of camping at PGE Pelton Park OR Promontory Park campgrounds. Approximate Retail Value ("ARV") of Prize: \$571.99. The winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use and other expenses incurred by accepting the Prize are the sole responsibility of the Winner. All Prize details are at PGE's sole discretion.

The Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at PGE's sole and absolute discretion. PGE reserves the right to substitute the Prize (or portion thereof) with one of comparable or greater value, at its sole and absolute discretion.

Notification: The Winner will be notified by e-mail, mail and/or telephone (in the sole discretion of PGE) by PGE. In the event that any Winner does not respond to any such notification within three (3) days of the date of issuance, a disqualification will result, the Prize will be forfeited and, at PGE's sole discretion and time permitting, an alternate Winner may be chosen from among all remaining eligible entries. The Winner may be required to submit his/her valid social security number (if applicable) and/or other identification to PGE and, if applicable, will be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Release of Publicity, within five (5) days of date of issuance. A disqualification will result, the Prize will be forfeited and, at PGE's sole discretion and time permitting, an alternate Winner may be randomly selected from among all remaining eligible entries if all required documents are not properly executed and returned within the specified period of time. Refusal or return of such documents as non-deliverable or Winner's noncompliance with these Official Rules will also result in disqualification and forfeiture of the Prize and, at PGE's sole discretion and time permitting, may cause an alternate Winner to be selected from among all remaining eligible entries.

Waiver of Liability/Publicity Release: By participating in the Sweepstakes and submitting an entry, each entrant agrees to (i) be bound by these Official Rules, including all entry requirements, and (ii) waive any and all claims against PGE, and any and all other companies associated with the Sweepstakes, and all of their respective officers, directors, employees, agents and representatives (collectively, "Released Parties") for any injury, damage or loss that may occur, directly or indirectly, in whole or in part, from the participation in the Sweepstakes or from the receipt or use of any Prize.

General Conditions: Released Parties are not responsible for stolen, late, incomplete, illegible, misdirected, lost, damaged, garbled, delayed, undelivered, inaccurate, postage-due or garbled entries, via e-mail or mail. Entries generated by a script, macro or other mechanical or automated means or by any means which subvert the entry process will be disqualified. Released Parties are not responsible for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility

or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the Prize or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Released Parties are not responsible for injury or damage to participants' or to any other person's computer related to or resulting from participating in this Sweepstakes or downloading materials from or use of the website.

Persons who tamper with or abuse any aspect of the Sweepstakes or website or attempt to undermine the legitimate operation of the Sweepstakes by cheating, deception or other unfair playing practices, or intend to annoy, abuse, threaten or harass any other entrant or PGE's representatives or who are in violation of these Official Rules, as solely determined by PGE, will be disqualified and all associated entries will be void. Any attempt to deliberately damage the content or operation of this Sweepstakes is unlawful and subject to legal action by PGE. PGE has the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Sweepstakes, and to resolve all disputes in its sole discretion. Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize, and (ii) disclaim any implied warranty. All disputes will be resolved under applicable U.S. laws in the County of Multnomah, state of Oregon without giving effect to choice of law or conflicted law principles (whether of the state of Oregon, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state of Oregon. PGE's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision.

PGE reserves the right, in its sole discretion, to cancel or suspend the Sweepstakes for any reason, including should virus, bugs, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Sweepstakes. In the event of cancellation, PGE may elect to identify the Winner[s] and award the Prize by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation.
