**Definitions.**

“You” and “Your” refer to the entity that has agreed to use the Calculator (as defined in the following sentence) in accordance with this Agreement.

“We” or PGE refers to Portland General Electric Company.

“Calculator” refers to the electric vehicle total cost of ownership calculator made available to You pursuant to this Agreement.

**Right of Access.** Your right to access and use the Calculator is personal to You, not transferable to any other person or entity, and You are only entitled to access and use the Calculator to calculate potential electric vehicle conversion costs for Your personal, non-commercial use and in accordance with applicable law and pursuant to the terms and conditions of this Agreement.

**IP Ownership.** PGE or its licensors retain all ownership and intellectual property rights in the Calculator. You do not acquire any ownership rights in the Calculator through its access or use.

**Restrictions on Use.** You may not use the Calculator to or permit a third party to

- copy, modify, or create derivative works of the Calculator, in whole or in part;
- remove or modify any Calculator markings or any notice of PGE or its licensors’ proprietary rights;
- make the Calculator available in any manner to any third party;
- bypass or breach any security device or protection used by the Calculator;
- cause or permit reverse engineering (unless required by law for interoperability), disassembly or decompilation of the Calculator (the foregoing prohibition includes but is not limited to review of data structures or similar materials produced by Calculators);
- create derivative works based on the Calculator;
- access or use the Calculator or Results for purposes of competitive analysis of the Calculator or the development or provision or use of a competing service or product
- modify, scrape, embed, or frame the Calculator without prior written permission
- input any sensitive information or data or any information or data that is (a) (i) attorney-client privileged communications or attorney work product; (ii) CEII; (iii) cyber asset information; (iv) critical cyber asset information; (v) real-time industrial controls system information; (vi) security plans for physical and cyber assets; (vii) transmission function information, (viii) payment card or personal health-related information, or (ix) any other information that requires the highest levels of access control and security protection; or (b) regulated by Law, including (i) data that is classified or used on the U.S. Munitions list, including software and technical data; (ii) articles, services and related technical data designated as defense articles or defense services; or (iii) ITAR (International Traffic in Arms Regulations) related data, (each of the foregoing, "**Prohibited Data**").

**No Backups.** THE CALCULATOR IS NOT INTENDED TO SERVE AS BACKUP OR STORAGE FOR ANY DATA THAT YOU INPUT, AND PGE AND ITS LICENSORS HAVE NO OBLIGATION OR LIABILITY FOR ANY LOSS, ALTERATION, DESTRUCTION, DAMAGE, CORRUPTION OR RECOVERY OF SUCH DATA.

**Restrictions on Access & Modifications.** We reserve the right to modify, suspend or discontinue, temporarily or permanently, your access to the Calculator, for any reason, with or without notice and without liability to you.

**Use.** You agree that you are solely responsible for Your use of the Calculator and results obtained therefrom. You understand that it is intended for informational purposes only.

**Indemnification.** To the extent permitted under applicable law, You will indemnify PGE, its affiliates, licensors, and their principals, agents and personnel against all costs, fees, expenses, damages and liabilities (including attorneys' fees and other defense costs) associated with any third party claim relating to or arising as a result of Your use of the Calculator.

**Revisions & Modifications to Terms.** We may revise the terms of this Agreement at any time, without notice to You, and You agree that You will be bound by the terms of the Agreement in force at the time you access the Calculator.

**Governing Law.** This Agreement is governed by the laws of the State of Oregon. The United Nations Convention on Contracts for the International Sale of Goods and the Uniform Computer Information Transactions Act do not apply to this Agreement.

**Miscellaneous.** You may not assign this agreement to any third party. The terms of the Agreement that by their nature should survive termination or expiration of the Agreement so survive. In the event that any term of this Agreement is found unenforceable or void, You agree that it shall be deemed severable from the Agreement and not affect the validity of the other terms herein.
