#### Environmental Permits and Land Use Authorizations for the Warm Springs Power Pathway Project

#### **THIS RFP AMENDMENT #1 IS RAISED TO:**

1. Respond to supplier questions; and
2. Amend the Mandatory Evaluation Criteria in Annex C of the RFP.

#### **THIS RFP AMENDMENT #1 IS HEREBY AMENDED AS FOLLOWS:**

1. **DELETE** section 2.2 from *Annex C - Mandatory Evaluation Criteria* on page 49 of the RFP, and **REPLACE** it with:
  - 2.2 The Offeror must have **at least two years** of experience prior to the solicitation closing date in working with Tribal Integrated Resource Management Plans and the Bureau of Indian Affairs.
    - a. The Offeror must provide brief project summaries to substantiate **at least two years** of experience. Each project summary must outline:
      - i. Project name, description, location, and an explanation of its similarity to the Project outlined in the SOW;
      - ii. The purpose of the project;
      - iii. Project start and end dates;
      - iv. The Offeror's specific role in that project;
      - v. The lead federal agency for that project;
      - vi. The specific tasks worked on;
      - vii. The specific deliverables submitted;
      - viii. A description of the project challenges and successes;
      - ix. List of key persons and their roles & responsibilities in that project;
      - x. Original and final contract amounts;
      - xi. Indicate whether the project had a compressed delivery schedule. Describe how the team adapted to deliver on time; and
      - xii. Client name, type of organization, email address, and telephone number. This client may be contacted by PGE for an evaluation and assessment of the Offeror's performance.



2. **DELETE** section 2.4 from *Annex C - Mandatory Evaluation Criteria* on page 50 of the RFP, and **REPLACE** it with:

- 2.4 The Offeror must have **at least two years** of experience prior to the solicitation closing date in using ArcGIS Online to develop applications, including setting up field maps and surveys for field data collection, and creating web maps and dashboards that will be used daily for project communication and collaboration.
- a. The Offeror must provide brief project summaries to substantiate **at least two years** of experience. Each project summary must outline:
- i. Project name, description, location, and an explanation of its similarity to the Project outlined in the SOW;
  - ii. The purpose of the project;
  - iii. Project start and end dates;
  - iv. The Offeror's specific role in that project;
  - v. The lead federal agency for that project;
  - vi. The specific tasks worked on;
  - vii. The specific deliverables submitted;
  - viii. A description of the project challenges and successes;
  - ix. List of key persons and their roles & responsibilities in that project;
  - x. Original and final contract amounts;
  - xi. Indicate whether the project had a compressed delivery schedule. Describe how the team adapted to deliver on time; and

3. **DELETE** section 2.6 from *Annex C - Mandatory Evaluation Criteria* on page 51 of the RFP, and **REPLACE** it with:

- 2.6 **[OFFEROR MUST COMPLETE CRITERION 2.6 IF SUBMITTING A PROPOSAL FOR OPTION 2]** The Offeror must have **at least three years** of experience prior to the solicitation closing date in Oregon land use permitting of high voltage transmission lines including completing an Energy Facility Siting Council ("EFSC") Application for a Site Certificate ("ASC").
- a. The Offeror must provide project dates and brief project summaries to substantiate **at least three years** of experience. Each project summary must include:
- i. Project name, description, location, and an explanation of its similarity to the Project outlined in the SOW;
  - ii. The purpose of the project;
  - iii. Project start and end dates;
  - iv. The Offeror's specific role in that project;
  - v. The lead federal agency for that project;
  - vi. The specific tasks worked on;
  - vii. The specific deliverables submitted;
  - viii. A description of the project challenges & successes;
  - ix. List of key persons and their roles & responsibilities in the project;
  - x. Original and final contract amounts;
  - xi. Indicate whether the project had a compressed delivery schedule. Describe how the team adapted to deliver on time; and
