Official Rules

PGE's OMSI Nancy Stueber Natural Sciences Hall VIP Reception Sweepstakes

1. Sweepstakes Description / How to Enter: NO PURCHASE NECESSARY TO ENTER OR WIN. PARTICIPATION CONSTITUTES PARTICIPANT'S FULL AND UNCONDITIONAL AGREEMENT TO AND ACCEPTANCE OF THESE OFFICIAL RULES. Sweepstakes is sponsored by Portland General Electric Company, 121 SW Salmon St., 1WTC058, Portland, OR 97204 ("PGE").

How to be entered: You may enter sweepstakes in one of two ways:

1. Completing the online entry form located here: <https://pge.jotform.com/230035032405943>, and be enrolled in at least one Flexible Load program which includes Peak Time Rebates, Smart Thermostat program and Time of Day.

2. To enter without completing the online entry form, legibly type or handprint on a postcard the words "PGE's OMSI Nancy Stueber Natural Sciences Hall VIP Reception Sweepstakes," along with your name, address, e-mail address (if you do not have an e-mail address, print "no e-mail address") and phone number to: "PGE's OMSI Nancy Stueber Natural Sciences Hall VIP Reception Sweepstakes, c/o Samantha Clemans Hoback, 121 SW Salmon St., 1WTC0407, Portland, OR 97204. No mechanically reproduced mail-in entries will be accepted.

Mail-in entries must be received by **11:59:59 p.m., PT, April 30, 2026**. Only one entry per address will be eligible for PGE customers who enter by mail. Incorrect, partial or late entries will not be accepted. PGE reserves the right to disqualify any person or e-mail address that submits multiple entries. All entries become the exclusive property of PGE and will not be acknowledged or returned. Any submission of robotic, automatic, or programmed entries, or any entries submitted by agencies, other third parties, or through other unapproved methods are void.

2. Sweepstakes period: The sweepstakes runs from **12 p.m. PT on April 1, 2026PT, 11:59:59 p.m., PT, April 30, 2026**.

3. Winner selection: Four (4) participants will be selected in a random drawing to be conducted within 30 (thirty) business days following April 30, 2026, from all eligible sweepstakes entries. Odds of winning depend on the number of entries received. The winner will be notified by e-mail or by phone, within five (5) business days following the drawing.

4. Requirements of winner: Winners of the "PGE's OMSI Nancy Stueber Natural Sciences Hall VIP Reception Sweepstakes, must claim the prize within ten (10) days of notification and in the method prescribed by the notification. Winners may be required to sign and return a release of liability, declaration of eligibility, and where lawful, a publicity consent agreement, within ten (10) days after notification. Participation in the sweepstakes (e.g., sharing a photo or submitting an entry) constitutes participant's full permission, except where prohibited by law, to use participant's submission and photo,



name, city, state and age for purposes of advertising, promotion and publicity without additional compensation. PGE reserves the right to request proof that potential winner is the authorized account holder of the e-mail account.

All federal, state, and local taxes, fees and duties are the sole responsibility of the winner.

To be eligible to win the sweepstakes, participants must be a registered account holder of Portland General Electric's services during the sweepstakes period and must be currently enrolled in one of PGE's Flexible Load programs including Peak Time Rebates, Smart Thermostat program or Time of Day and must be listed on the PGE account as either the main customer or an authorized user.

Employees, officers, directors and agents of PGE, its affiliates, subsidiaries, advertising, promotion and fulfillment agencies, their immediate family members and persons living in their same household, are not eligible to participate in the sweepstakes. PGE reserves the right to substitute any prize with another prize of equal or greater value if the advertised prize is not available.
