### INTEGRATED RESOURCE PLANNING


**Least-Cost Planning started in Oregon in 1989** 

#### Today's IRP Guidelines:

- Best balance COST and RISK
- Significant **INVOLVEMENT OF THE PUBLIC**
- Consistent with the LONG-RUN PUBLIC INTEREST



#### THE PLANNING PROCESS




Best balance of cost and risk

#### What's in an Action Plan?

**Technically:** The actions that the company plans to take in the next 2-4 years to meet customer needs in a manner that best balances cost and risk.

#### **Customer Actions**

High level target-setting for energy efficiency, demand response, and other programs that provide opportunities for customers to participate in the grid.


#### **Major Resource Actions**

Plans to pursue major resources, such as large wind, solar, or storage facilities, including building new resources or contracting for existing resources.

**Practically:** The Action Plan reflects values, priorities, intentions, and compromises between many perspectives. It impacts how peoples' energy needs will be met, with what types of resources, how much it may cost, what the environmental impacts may be, and to some extent, what opportunities people may have to more actively manage their energy demand and impact. This is why input is so critical to the process.




#### PGE's Public Process

#### What we heard

#### participant engagement in the 2019 IRP

#### Strong participation across a wide range of groups and individuals

• 14 public meetings, written comments, five unique portfolio requests

#### participant values shared at the outset of our process

- Cost and risk
- Environmental sustainability
- Transparency

#### **Key topics of interest raised throughout the process**

- External Studies: Decarbonization Study
- Resource Options: Wind, storage, and solar + storage assumptions
- Portfolio Analysis: Portfolio requests, portfolio optimization, scoring metrics
- Action Plan: Renewable and capacity actions
- Other: Transmission, procurement activities, Colstrip, and community engagement

- Adjust engagement to fit participant needs
