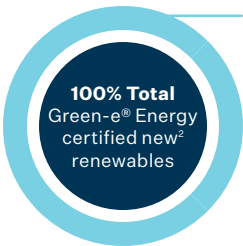


# 2025 Green Future<sup>SM</sup> Enterprise prospective product content label<sup>1</sup>



Green Future Enterprise is a Green-e<sup>®</sup> Energy certified Renewable Energy Certificate (REC) product. Renewable Energy Certificates (RECs) do not contain electricity. A REC represents the environmental benefits of 1 megawatt-hour (MWh) of renewable energy that can be paired with electricity. You can purchase RECs up to 100% of your PGE served electricity load, subject to availability, with a minimum purchase of 1,000 kWh per month. PGE is supplying your electricity. Green-e<sup>®</sup> Energy has only certified the RECs, which may be sourced from outside of your local electricity distribution area. ## Green Future Enterprise price, terms and conditions

<b>What is my contract length?</b>	Your Green Future Enterprise contract is month-to-month unless otherwise specified in your agreement.
<b>How much will Green Future Enterprise cost?</b>	\$5.90 per MWh (1,000 kWh).
<b>Will my rates change over time?</b>	The price of Green Future Enterprise may change with evolving REC market conditions and program demand. You will be notified of any price change in advance.
<b>What other fees might I be charged?</b>	You must also pay all applicable federal, state or local taxes.
<b>How will I be billed?</b>	Your Green Future Enterprise charge will be listed as a separate line item on your monthly PGE bill, or you can choose to be invoiced separately on a monthly or annual basis. In either case, this charge is in addition to your regular electricity bill.
<b>Can I cancel my participation?</b>	You can cancel at any time with no fee. There is no minimum contract length.
