The Report is available free of charge at Goldman Sachs International, Zweigniederlassung Frankfurt, MesseTurm, Friedrich-Ebert-Anlage 49, 60308 Frankfurt am Main.

The information contained in the Base Prospectus shall be supplemented as follows:

In the Base Prospectus all references to the "Registration Document of Goldman Sachs International dated 10 January 2018 (as supplemented by the supplements dated 10 April 2018, 26 April 2018 and 4 June 2018)" shall be read as reference to the "Registration Document of Goldman Sachs International dated 10 January 2018 (as supplemented by the supplements dated 10 April 2018, 26 April 2018, 4 June 2018 and 20 July 2018)".

*1. In the Base Prospectus in section "**VIII. Important information about the Guarantor**" on page 759 the following point shall be added at the end of the list contained in the first paragraph:*
