The significant new factor resulting in this supplement (the "Supplement") to the Prospectuses in the table below (page 9, the "Table") is the publication of the unaudited quarterly financial information of Goldman Sachs Bank Europe SE dated 13 November 2025 for the third quarter of 2025 ended 30 September 2025 (the "GSBE Third Quarter Financial Information 2025") on 13 November 2025. The GSBE Third Quarter Financial Information 2025 is incorporated by reference into the Prospectuses listed in the Table below. The required amendments to the Prospectuses are set out in Section A of the Supplement.

Furthermore, by way of the Supplement the references to "Clearstream Banking AG" in the Prospectuses in the table below will be amended to "Clearstream Europe AG" following the renaming in Clearstream Europe AG with effect from 26 September 2025, as described in Section B of the Supplement. These amendments do not constitute a significant new factor, material mistake or material inaccuracy within the meaning of Article 23 (1) of the Prospectus Regulation.
